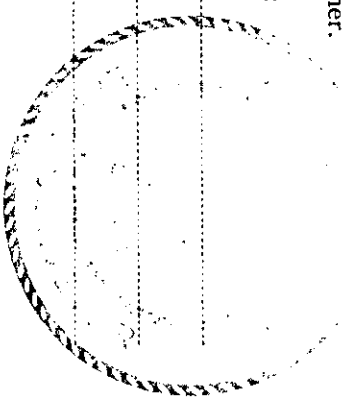
as described hereon; and that from this evidence I established a new monument and accessories as described hereon to perpetuate the original location of this corner.

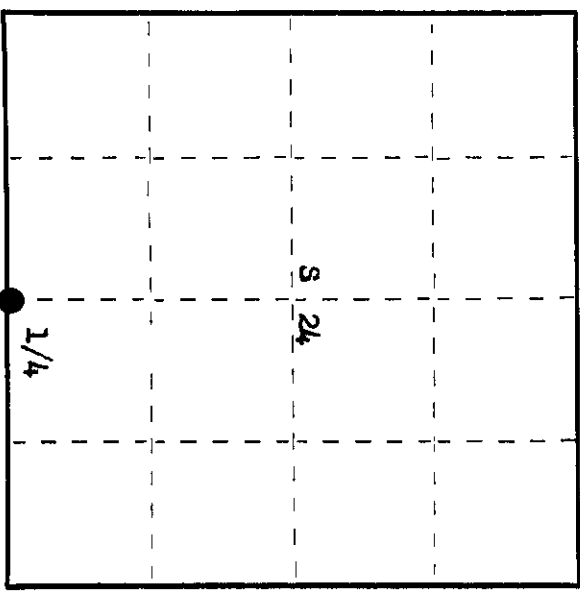

History of original corner establishment:

Original Corner established by Wm. E. Dougherty, Deputy Surveyor, in 1863, from which Ash 8" bears N 10° W 10 links and Ash 15" bears S 21° E 47 links. Corner recovered by D.H. Vaughan, County Surveyor, in 1910. Found the original BTs and set new post. Corner recovered by H.C. Lawrence, Registered Land Surveyor, in 1947. Set new post, but no record of any NBTs.

Description of corner evidence found:

Recovered old 3" squared cedar post, still standing, no scribbing visible. Also recovered a 2 1/2" iron pipe, with brass cap, untamped, lying beside it. No evidence of the original BTs or any subsequent BTs.

Description of monument and accessories I established to perpetuate the original location of this corner.

Replaced old post with 2 1/2" Bernitsen A-1 Federal Monument, stamped:  
Monument projects 24" above ground.  
NBTs - Maple 7" N 32° E 49.3 links  
Cedar 9" S 19° E 84.2 links  
Cedar 7" S 35° W 62 links, all scribbed 1/4 BT.  
Corner sets south 60 links from Bug Lake Creek.
