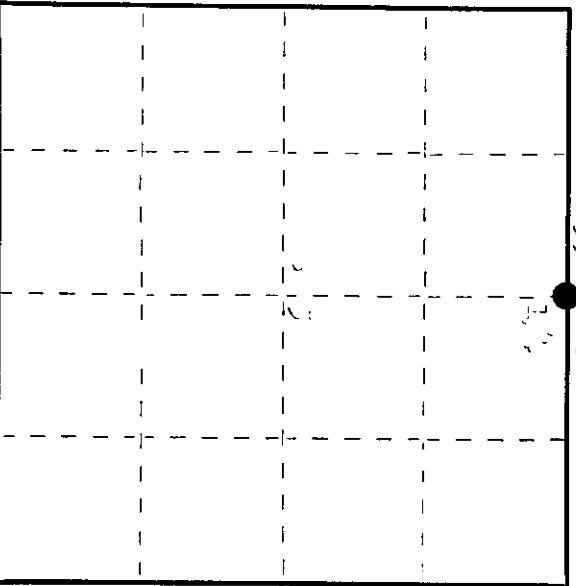
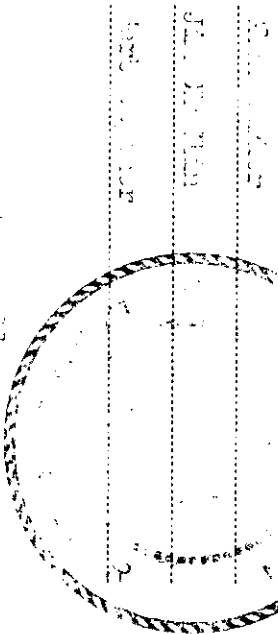

Lawrence, County Surveyor, Wis., 1872 from 110' corner recovered by H.J. Lawrence, registered land surveyor. Set 3rd cedar post, no monument of any BS established.
