

Oct. 7, 2014: On OCS Map No. C-2834, Gregory S. Maines, PLS identifies corner as Oneida Co. aluminum monument, found.

July 8, 2019: I found and accepted the record monument, a 2.4" diam. aluminum pipe with an unmarked 3.3" diam. Oneida Co. aluminum cap 2" beneath the water surface. A high 1.8" diam. iron pipe is North and adjacent to the monument. As the corner is located in a knee-deep marsh, I was unable to establish accessories a reasonable distance from the corner. I found two white vinyl sign posts adjacent to the monument.

The coordinate value shown has been verified by at least one of the following methods: 1) comparison to a previously CPS determined published value; 2) the value is the average of two or more CPS observations at a markedly different time; 3) one or more distances were measured back to the CPS observed corner from temporary CPS observed offset locations.
