



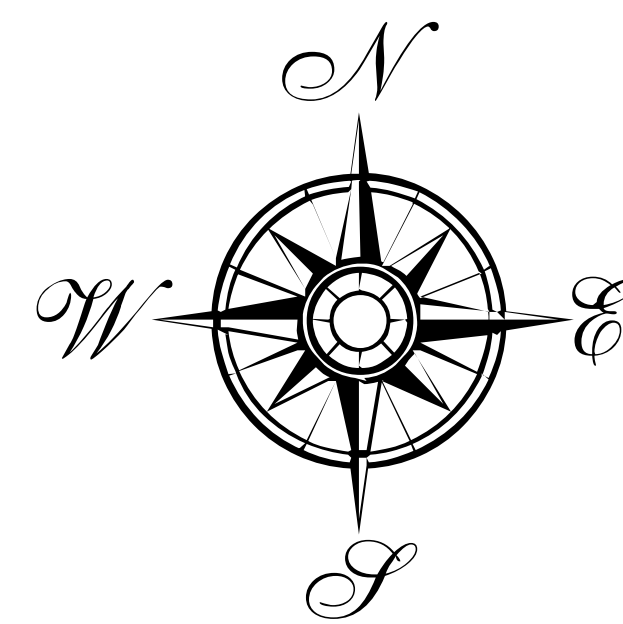

THERE IS AN OVERLAP BETWEEN ST 580-582 AND TRACT WITH 1411 (2012) FOR THIS AREA AND IS IN THE RESERVATION FOR THE STELLA LAKE PLAT AND SHOULD BE MAPPED WITH AID OF SURVEY DATA FROM BOOKER.
