

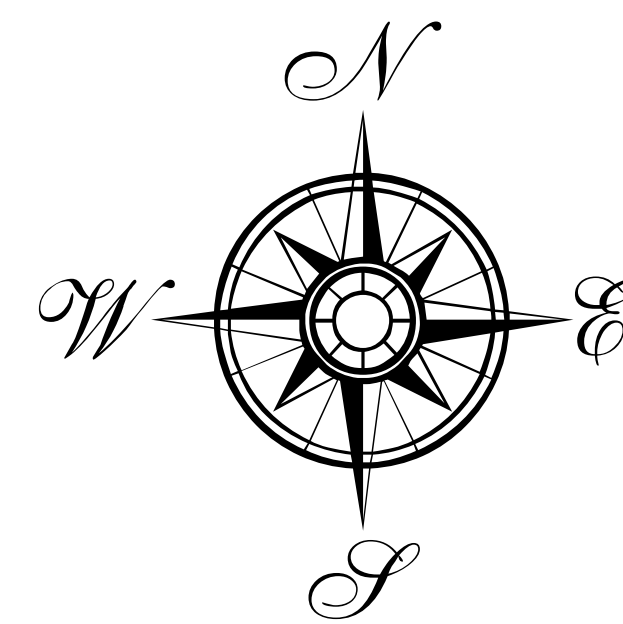
LT 314-1, -2, -3 WERE PLACED BY MATZ SUBDIVISION PLAT.

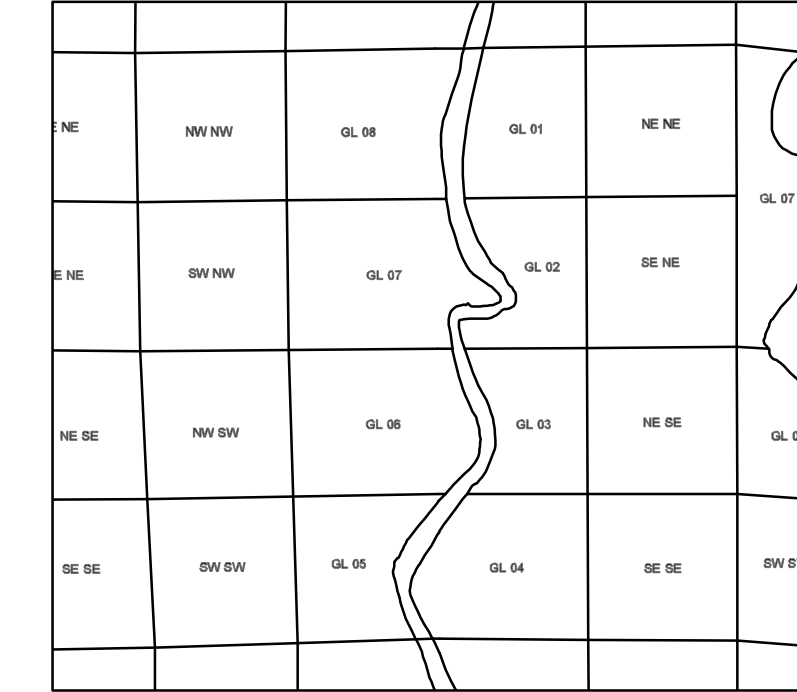
