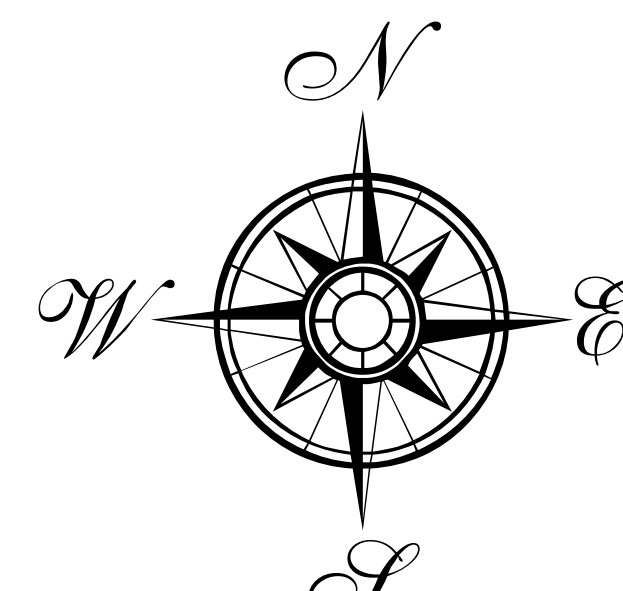
THE NE 1/4 OF SECTION 8 HAS BEEN REMOVED INTERNALLY.
