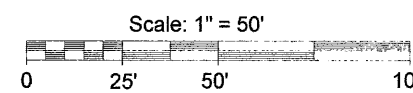

DESCRIPTION

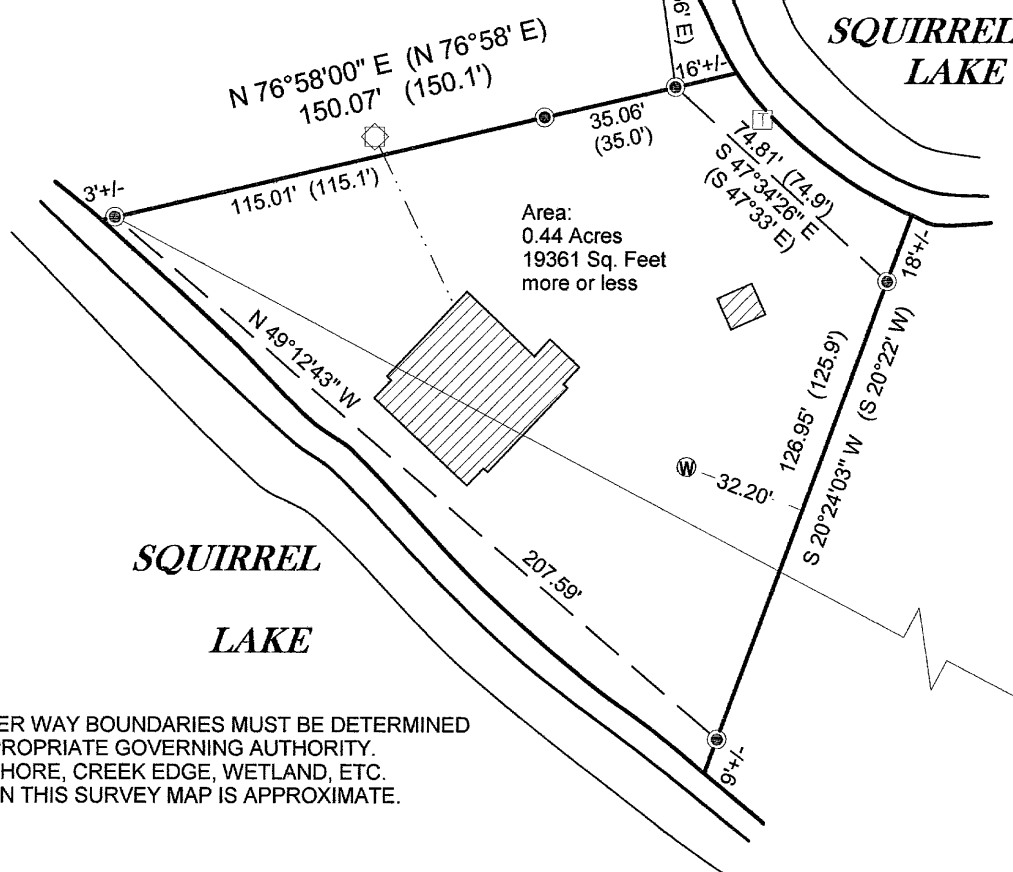
Part of Lot 41 of the Plat of Squirrel Lake Island, Section 17, Township 39 North, Range 5 East, town of Minocqua, Oneida County, Wisconsin, shown on a survey map by McMullen & Associates, Inc. of Minocqua, Wisconsin dated the 17th day of October, 2005, with a Job Number of 205090, more particularly described as follows:

Commencing at a Meander Corner between Section 17 and Section 20 marked by an Oneida County Aluminum Monument near the Easterly shore of Squirrel Lake; thence leaving said lake shore North 62°06'54" West (Assumed North, based on the Northerly line of parcel which bears North 76° 58' 00" East) a distance of 2166.53' to a 1 1/2" Iron pipe on Squirrel Lake Island near the shore of Squirrel Lake, said iron pipe being the POINT OF BEGINNING.

Thence leaving said lake shore North 76° 58' 00" East, a distance of 150.07 feet to a 1 1/2" iron pipe near said lake shore; thence meandering along said lake shore South 47° 34' 26" East, a distance of 74.81 feet to a 1 1/2" iron pipe; thence leaving said lake shore South 20° 24' 03" West, a distance of 126.95 feet to a 1 1/2" iron pipe near said lake shore; thence meandering along said lake shore North 49° 12' 43" West, a distance of 207.59 feet to the POINT OF BEGINNING.

Said described tract containing 0.44 acre (19361 square feet), more or less.

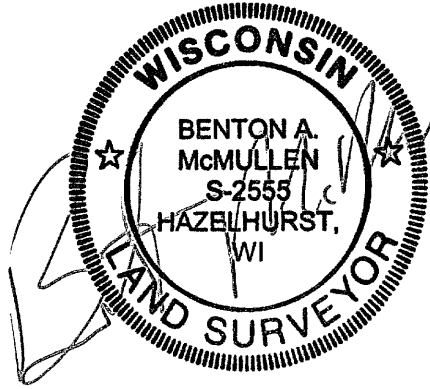
