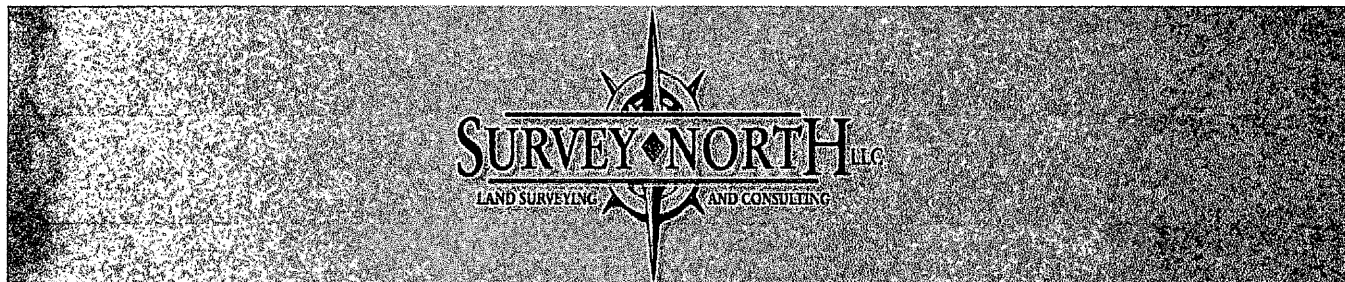
Center 1/4 Corner

Part of Government Lot 4, Section 36, Township 37 North, Range 8 East, town of Pine Lake, Oneida County, Wisconsin shown on a survey map by Survey North, LLC dated the 24th Day of May, 2011 having a Job No. of Paulsen11R3 and more particularly described as follows:

Commencing at the North 1/4 Corner of Section 36 marked by a P.K. Nail; thence South 1° 09' 01" West (Assumed North, based on the Southerly line of Parcel -1- shown on said Survey Map which bears South 83° 15' 00" West), a distance of 1341.77 feet to the Center-North 1/16 Corner of said Section marked by a P.K. Nail.; thence South 1° 13' 59" West, a distance of 368.49 feet to a point that bears North 1° 13' 59" East, 973.50 feet of the Center 1/4 Corner of said Section; thence South 83° 15' 00" West, a distance of 818.40 feet to a 1.900" Iron Pipe on the Southerly and Westerly right-of-way of Trails End Loop, said point being the POINT OF BEGINNING.

Thence continuing South 83° 15' 00" West, a distance of 109.60 feet to a 2.375" Iron Pipe near the Easterly shore of the Wisconsin River; thence meandering along said river North 35° 47' 35" West, a distance of 157.60 feet to a 1.315" Iron Pipe; thence leaving said river North 86° 16' 00" East, a distance of 168.97 feet to a 1.050" Iron Pipe on the Westerly right-of-way of Trails End Loop; thence along said right-of-way South 14° 25' 33" East, a distance of 130.05 feet to the POINT OF BEGINNING.
