

DESCRIPTION (PLATTED ROAD)

Part of the platted road of the recorded plat of Sylvan Shores in Government Lot 2, Section 3, Township 38 North, Range 6 East, town of Hazelhurst and in Government Lot 1, Section 34, Township 39 North, Range 6 East, town of Minocqua all in Oneida County, Wisconsin as shown on a survey map by McMullen & Associates, Incorporated of Minocqua, Wisconsin dated the 2nd day of February, 2007 with a job number of 206097 and revise on June 16, 2017 with a job number of 217030 more particularly described as follows:

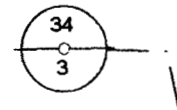
Commencing at the 1/4 corner common to said sections marked by a 1.050" iron pipe; thence South 88° 14' 19" East (Assumed North, based on the southerly right of way line of said platted road described herein which bears South 88° 13' 45" East), a distance of 874.60 feet to a point on the westerly right of way of said platted road (not constructed); thence along said westerly right of way South 25° 22' 16" East, a distance of 11.61 feet to a 1.315" iron pipe, said point being the POINT OF BEGINNING.

Thence continuing South 25° 22' 16" East along said line, a distance of 10.84 feet to a 0.500" iron rod; thence along the southerly right of way line of said platted road South 88° 13' 45" East, a distance of 249.37 feet to a 1.315" iron pipe; thence crossing said platted road North 31° 08' 22" East, a distance of 34.42 feet to a point on the northerly right of way of said platted road; thence along said right of way North 88° 13' 45" West, a distance of 247.92 feet to a point; thence crossing said platted road South 50° 35' 53" West, a distance of 30.92 feet to the POINT OF BEGINNING.

Subject to any easements, restrictions, or rights of way of record or of use and subject to the right of way for Sylvan Shore Road.

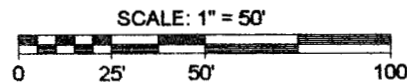

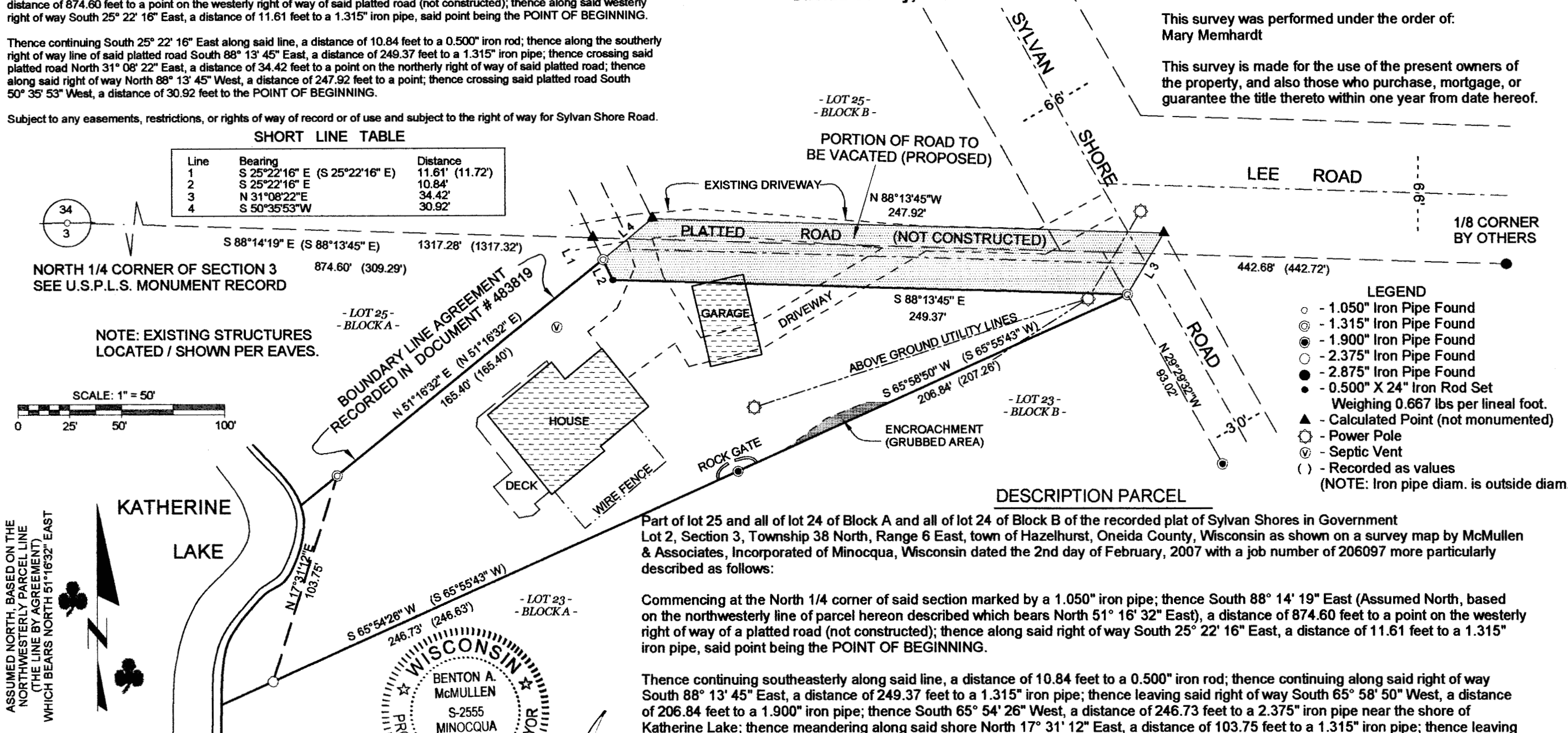

Commencing at the North 1/4 corner of said section marked by a 1.050" iron pipe; thence South 88° 14' 19" East (Assumed North, based on the northwesterly line of parcel hereon described which bears North 51° 16' 32" East), a distance of 874.60 feet to a point on the westerly right of way of a platted road (not constructed); thence along said right of way South 25° 22' 16" East, a distance of 11.61 feet to a 1.315" iron pipe, said point being the POINT OF BEGINNING.

Thence continuing southeasterly along said line, a distance of 10.84 feet to a 0.500" iron rod; thence continuing along said right of way South 88° 13' 45" East, a distance of 249.37 feet to a 1.315" iron pipe; thence leaving said right of way South 65° 58' 50" West, a distance of 206.84 feet to a 1.900" iron pipe; thence South 65° 54' 26" West, a distance of 246.73 feet to a 2.375" iron pipe near the shore of Katherine Lake; thence meandering along said shore North 17° 31' 12" East, a distance of 103.75 feet to a 1.315" iron pipe; thence leaving said shore along a line by agreement recorded in document number 483819 at the Oneida County Register of Deeds office North 51° 16' 32" East, a distance of 165.40 feet to the POINT OF BEGINNING.
