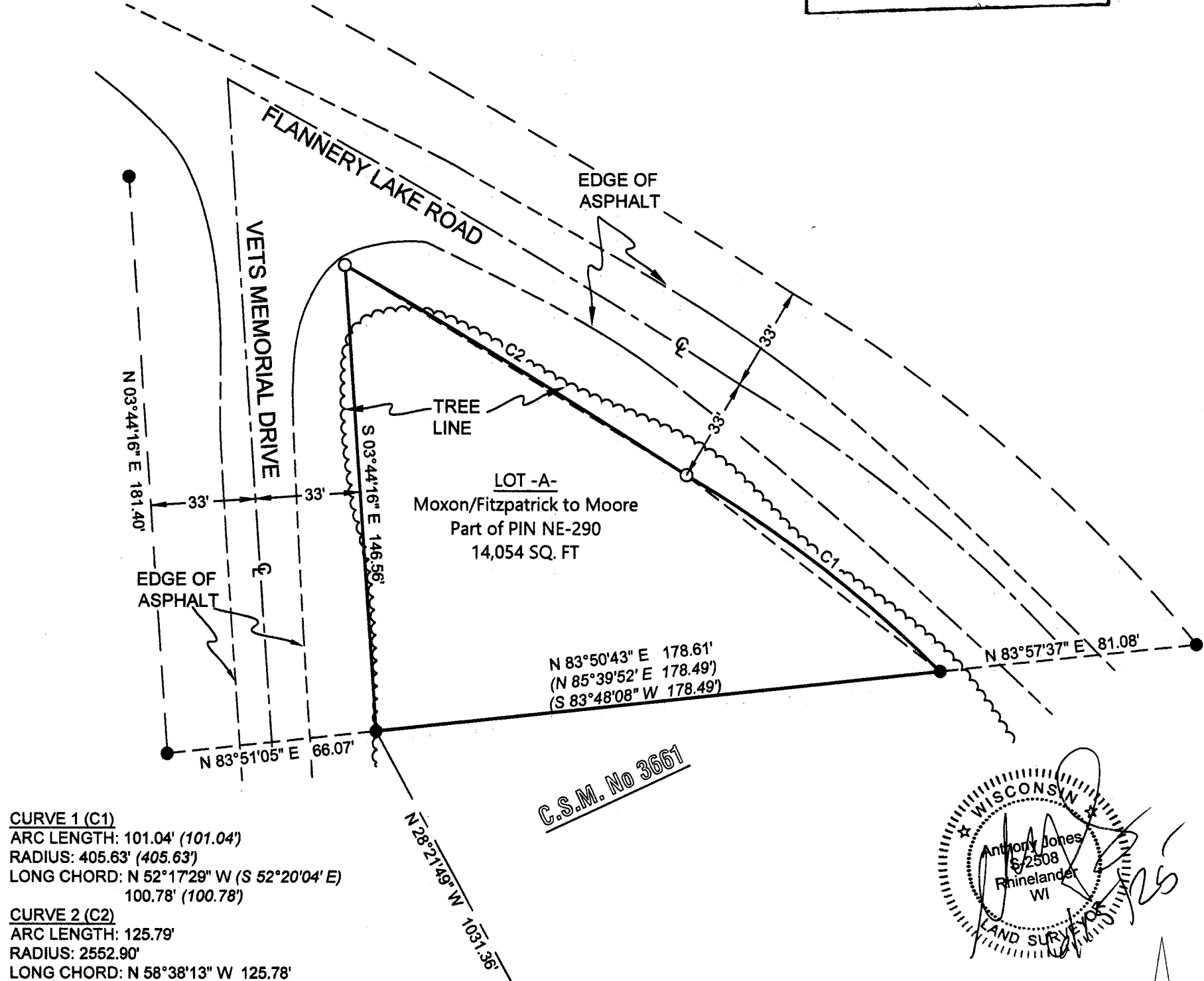

PART OF THE NE 1/4 OF THE SW 1/4, SECTION 28, TOWNSHIP 37
NORTH, RANGE 8 EAST, ONEIDA COUNTY, WISCONSIN.

DESCRIPTION: MOXON/FITZPATRICK TO MOORE
A PARCEL OF LAND LOCATED IN THE NORTHEAST 1/4 OF THE SOUTHWEST 1/4 OF SECTION 28, TOWNSHIP 37 NORTH, RANGE 08 EAST, TOWN OF NEWBOLD, ONEIDA COUNTY, WISCONSIN, NOW MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT A MEANDER CORNER ON THE WEST SHORE OF FLANNERY LAKE ON THE SOUTH LINE OF SECTION 28, TOWNSHIP 37 NORTH, RANGE 08 EAST, MARKED BY A FOUND GOVERNMENT LAND OFFICE BRASS DISC, THENCE N 28°21'49" W, 1031.36 FEET TO A FOUND 3/4 INCH IRON ROD ON THE EAST RIGHT OF WAY LINE OF VETS MEMORIAL DRIVE, BEING THE NORTHWEST CORNER OF LOT 1, ONEIDA COUNTY CERTIFIED SURVEY MAP (CSM) No. 3661, AND THE POINT OF BEGINNING.

- THENCE ALONG THE NORTH LINE OF SAID LOT 1 OF CSM No. 3661, N 83°50'43" E, 178.61 FEET TO A FOUND 3/4 INCH IRON ROD ON THE SOUTHWEST RIGHT OF WAY OF FLANNERY LAKE ROAD;
- THENCE ALONG THE SAID SOUTHWEST RIGHT OF WAY OF FLANNERY LAKE ROAD, 101.04' ALONG THE ARC OF A CURVE TO THE LEFT, WITH A RADIUS OF 405.63 FEET AND A LONG CHORD BEARING AND DISTANCE OF N 52°17'29" W, 100.78 FEET TO A SET 1 INCH BY 18 INCH IRON PIPE;
- THENCE CONTINUING ALONG THE SAID SOUTHWEST RIGHT OF WAY OF FLANNERY LAKE ROAD, 125.79 FEET ALONG THE ARC OF A CURVE TO THE LEFT, WITH A RADIUS OF 2552.90 FEET AND A LONG CHORD BEARING AND DISTANCE OF N 58°38'13" W, 125.78 FEET TO A SET 1 INCH BY 18 INCH IRON PIPE AT THE INTERSECTION OF THE SOUTHWEST RIGHT OF WAY OF FLANNERY LAKE ROAD AND THE EAST RIGHT OF WAY OF VETS MEMORIAL DRIVE;
- THENCE ALONG THE SAID EAST RIGHT OF WAY OF VETS MEMORIAL DRIVE, S 03°44'16" E, 146.56 FEET TO THE POINT OF BEGINNING.

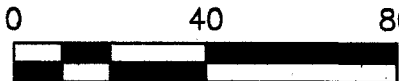

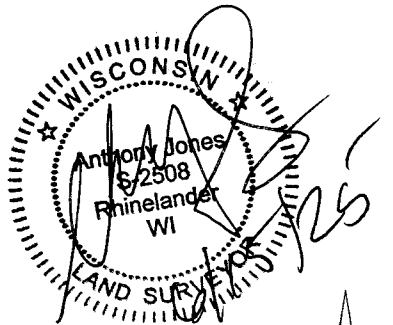
