

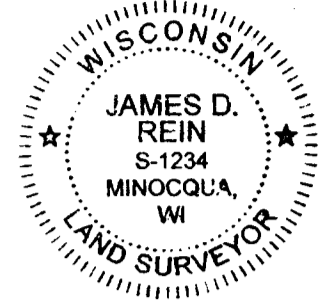

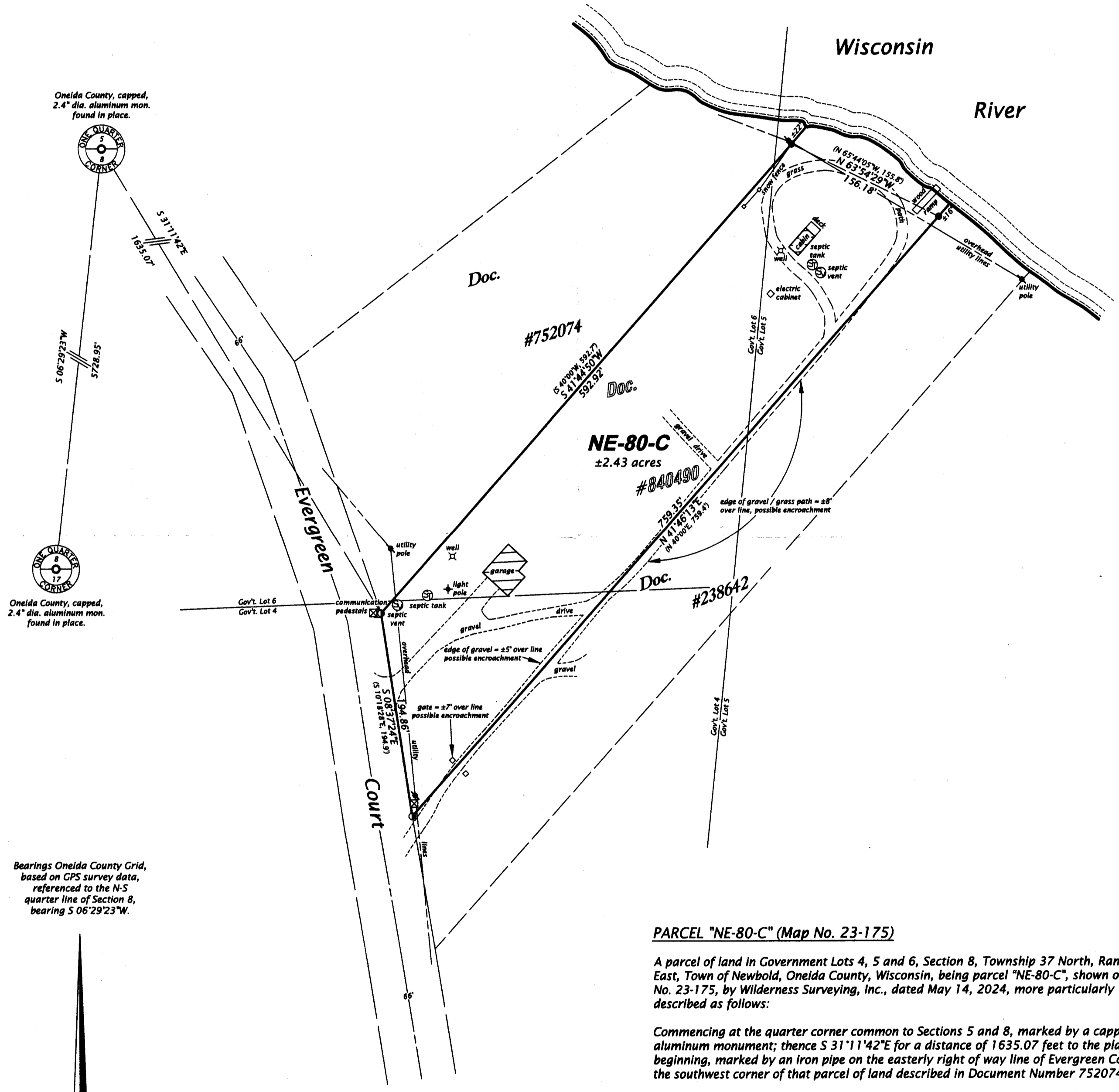

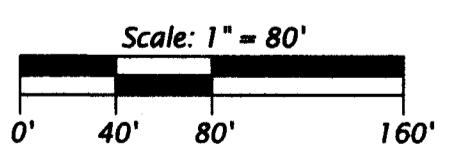

**PARCEL "NE-80-C" (Map No. 23-175)**

A parcel of land in Government Lots 4, 5 and 6, Section 8, Township 37 North, Range 8 East, Town of Newbold, Oneida County, Wisconsin, being parcel "NE-80-C", shown on Map No. 23-175, by Wilderness Surveying, Inc., dated May 14, 2024, more particularly described as follows:

Commencing at the quarter corner common to Sections 5 and 8, marked by a capped aluminum monument; thence S 31°11'42"E for a distance of 1635.07 feet to the place of beginning, marked by an iron pipe on the easterly right of way line of Evergreen Court at the southwest corner of that parcel of land described in Document Number 752074.

Thence S 08°37'24"E for a distance of 194.86 feet along the easterly right of way line of Evergreen Court to an iron pipe at the northwest corner of that parcel of land described in Document Number 238642; thence N 41°46'13"E for a distance of 759.35 feet along the northwesterly line of that parcel of land described in Document Number 238642, to an iron pipe near the southerly bank of the Wisconsin River; thence meandering along the bank, N 63°54'29"W for a distance of 156.18 feet to an iron pipe on the southeasterly line of that parcel of land described in Document Number 752074; thence S 41°44'50"W for a distance of 592.92 feet along the southeasterly line of that parcel of land described in Document Number 752074, to the place of beginning.

The above described lateral lot lines extend to the southerly bank of the Wisconsin River; and includes all those lands lying between the meander line and the bank.

Together with and subject to covenants, easements, and restrictions of record.

Said property contains 2.43 acres, more or less.
