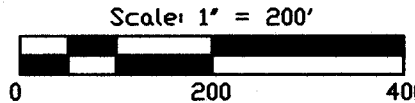
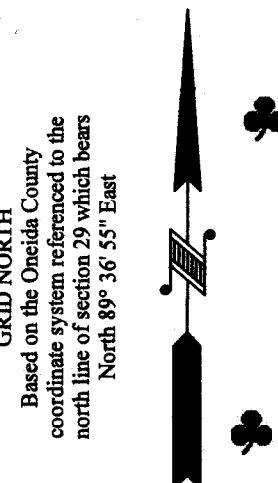

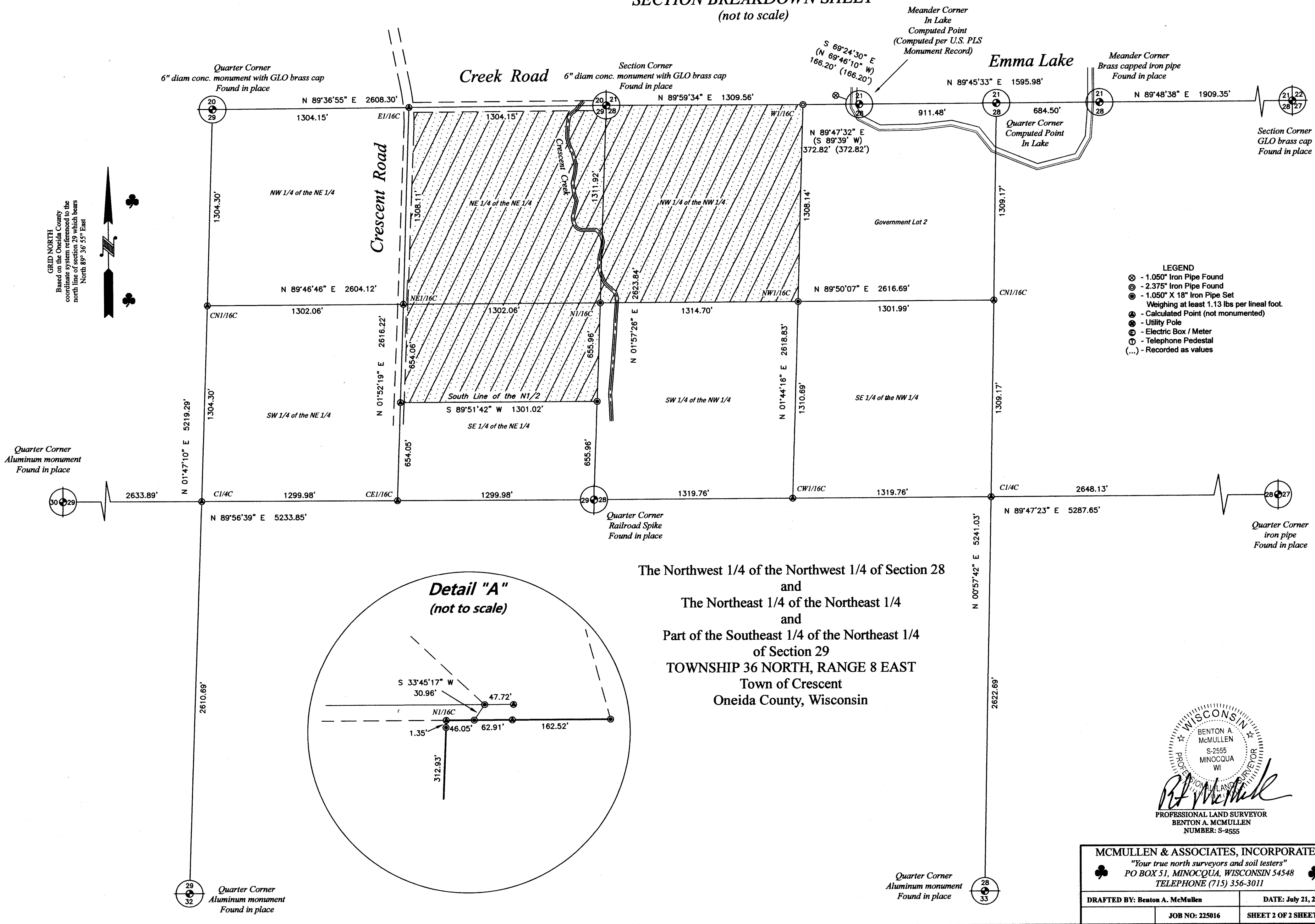

- 2) IRON PIPE DIAMETERS GIVEN ARE OUTSIDE DIAMETERS.
