

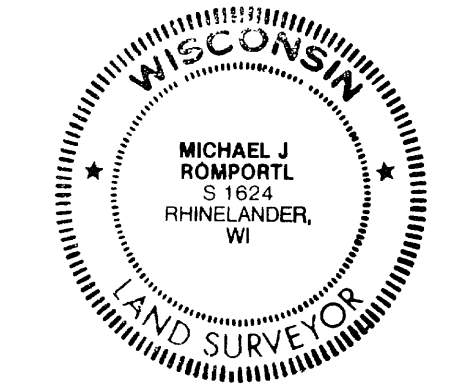

SURVEYORS CERTIFICATE

I, MICHAEL J ROMPORTL, WISCONSIN REGISTERED LAND SURVEYOR, DO HEREBY CERTIFY THAT I HAVE SURVEYED, DIVIDED, AND MAPPED THIS COUNTY PLAT LOCATED IN GOVERNMENT LOTS 1 & 2, SECTION 21, TOWNSHIP 38 NORTH, RANGE 8 EAST, TOWN OF NEWBOLD, ONEIDA COUNTY, WISCONSIN, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS, COMMENCING AT A 2" IRON PIPE MARKING THE EAST 1/4 CORNER OF SAID SECTION 21, THENCE N 1°00'00"W ALONG THE EAST LINE OF SECTION 21 A DISTANCE OF 1211 26' TO A 1" IRON PIPE ON THE SOUTHERLY RIGHT-OF-WAY LINE OF RANCH ROAD, THENCE S 89°39'30"W ALONG SAID RIGHT-OF-WAY LINE A DISTANCE OF 289.24' TO AN IRON PIPE AND THE POINT OF BEGINNING, THENCE CONTINUING S 89°39'30"W ALONG SAID RIGHT-OF-WAY LINE A DISTANCE OF 883 35' TO AN IRON PIPE, THENCE LEAVING SAID RIGHT-OF-WAY LINE S 0°47'40"E A DISTANCE OF 1102 54' TO AN IRON PIPE, THENCE S 35°06'40"E A DISTANCE OF 251 13' TO AN IRON PIPE ON THE NORTHERLY SHORE OF TOM DOYLE LAKE, THENCE ALONG A MEANDER LINE OF TOM DOYLE LAKE N 16°20'50"E A DISTANCE OF 409 65' TO AN IRON PIPE, THENCE N 81°29'15"E A DISTANCE OF 36 94' TO AN IRON PIPE, THENCE S 77°36'25"E A DISTANCE OF 145 00' TO AN IRON PIPE, THENCE S 57°36'55"E A DISTANCE OF 270 00' TO AN IRON PIPE, THENCE S 78°52'00"E A DISTANCE OF 160 00' TO AN IRON PIPE AND THE END OF THE MEANDER LINE, THENCE LEAVING THE SHORE OF TOM DOYLE LAKE N 14°12'00"E A DISTANCE OF 246 85' TO AN IRON PIPE, THENCE N 1°00'00"W A DISTANCE OF 882 03' TO THE POINT OF BEGINNING ALSO INCLUDING THOSE LANDS LYING BETWEEN THE ABOVE DESCRIBED MEANDER LINE AND THE ORDINARY HIGH WATER MARK OF TOM DOYLE LAKE SUBJECT TO EASEMENTS, RESERVATIONS, AND RESTRICTIONS AND RIGHT-OF-WAYS OF RECORD THAT I HAVE MADE SUCH SURVEY UNDER THE DIRECTION OF J O G INC AND THAT THE ABOVE MAP IS A TRUE AND CORRECT REPRESENTATION OF THE LANDS SURVEYED TO THE BEST OF MY KNOWLEDGE AND BELIEF THAT I HAVE FULLY COMPLIED WITH CHAPTER 910 OF THE ONEIDA COUNTY ZONING AND SHORELANDS PROTECTION ORDINANCE

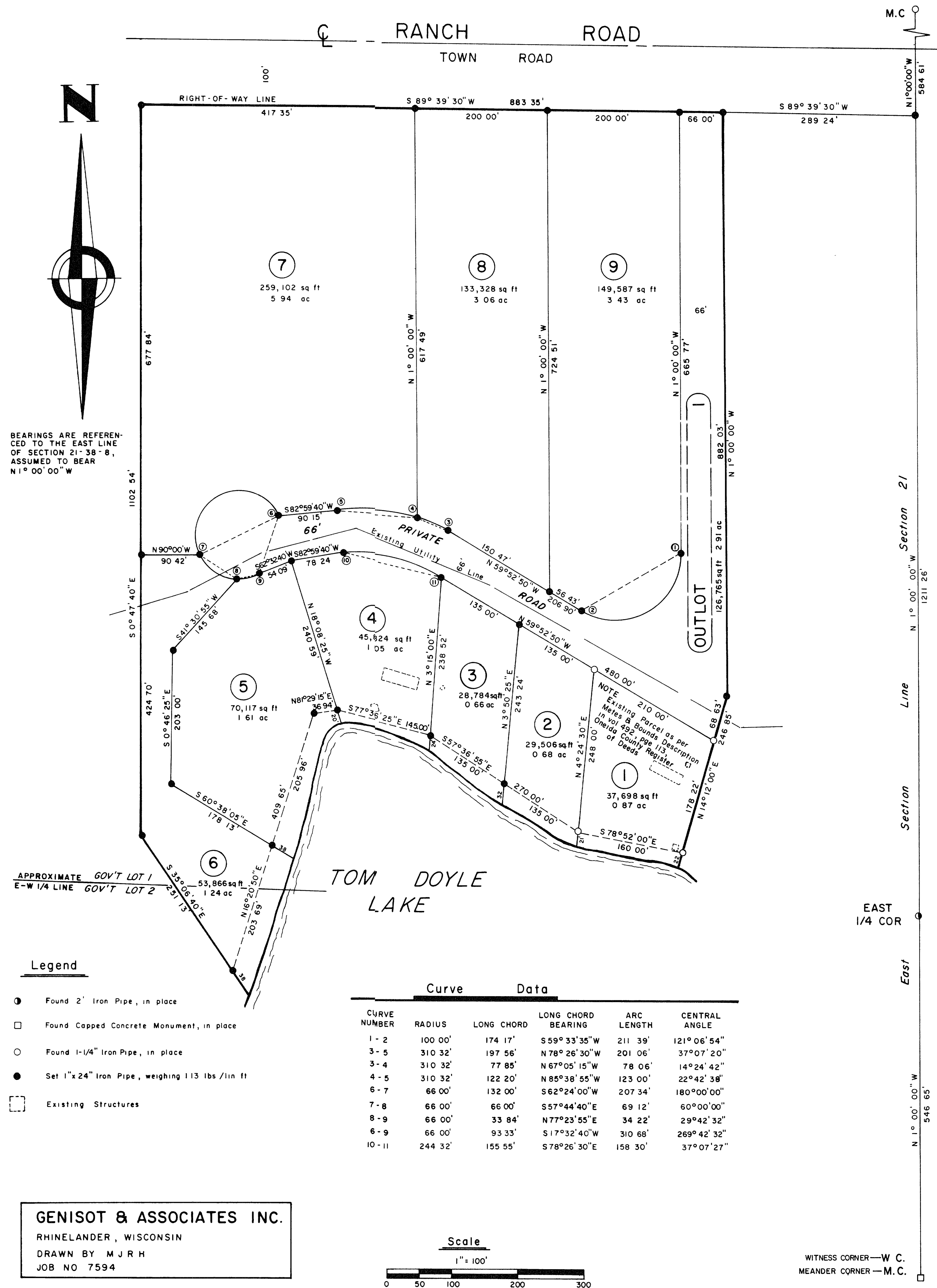
