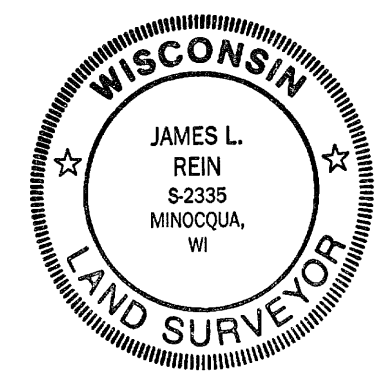

Parcel B-1 (Map No. 99-144-2)

A parcel of land in the Northeast Quarter of the Northeast Quarter, Section 7, Township 39 North, Range 7 East, Woodruff Township, Oneida County, Wisconsin, being parcel "B-1" as shown on Map No. 99-144-2 by Wilderness Surveying, Inc., dated May 24, 2000, more particularly described as follows:

Commencing at the corner common to Sections 5, 6, 7 and 8, marked by a brass capped iron pipe; thence North 87 degrees 37 minutes 53 seconds West for a distance of 721.77 feet along the north line of the Northeast Quarter of the Northeast Quarter to the place of beginning, marked by an iron pipe.

Thence South 00 degrees 20 minutes 08 seconds East for a distance of 545.63 feet to an iron pipe on the northerly right of way line of County Highway "J"; thence North 66 degrees 49 minutes 41 seconds West for a distance of 600.00 feet along said northerly right of way line to an iron pipe; thence North 23 degrees 10 minutes 19 seconds East for a distance of 355.08 feet to an iron pipe on the north line of the Northeast Quarter of the Northeast Quarter; thence South 87 degrees 37 minutes 53 seconds East for a distance of 409.03 feet to the place of beginning.

Commencing at the corner common to Sections 5, 6, 7 and 8, marked by a brass capped iron pipe; thence North 87 degrees 37 minutes 53 seconds West for a distance of 1130.80 feet along the north line of the Northeast Quarter of the Northeast Quarter to the place of beginning, marked by an iron pipe.

Thence South 23 degrees 10 minutes 19 seconds West for a distance of 355.08 feet to an iron pipe on the northerly right of way line of County Highway "J"; thence North 66 degrees 49 minutes 41 seconds West for a distance of 545.63 feet along said northerly right of way line to an iron pipe; thence South 00 degrees 20 minutes 08 seconds East for a distance of 600.00 feet along said northerly right of way line to an iron pipe; thence North 66 degrees 49 minutes 41 seconds West for a distance of 600.00 feet along said northerly right of way line to an iron pipe; thence North 23 degrees 10 minutes 19 seconds East for a distance of 355.08 feet to an iron pipe on the north line of the Northeast Quarter of the Northeast Quarter; thence South 87 degrees 37 minutes 53 seconds East for a distance of 409.03 feet to the place of beginning.
