SURVEYOR'S NOTE:
THE PLAT OF PELICAN SOUTH SHORE RESORTS ADDITION IS AMBIGUOUS. ON THE PLAT IT SHOWS ALL LOTS AT 100 FEET IN WIDTH. IN THE SURVEYORS CERTIFICATE IT STATES THAT ALL LOTS ARE 100 FEET WIDE WITH THE EXCEPTION OF LOT 19 WHICH IS 200 FEET WIDE. THE FIELD CONDITIONS AND THE LAYOUT OF THE LOTS DOES NOT ALLOW FOR ANY OF THE LOTS TO BE 200 FEET WIDE. THE ORIGINAL PLAT OF PELICAN SOUTH SHORE RESORTS SHOWS ALL LOTS BEING 100 FEET IN WIDTH, THE PLAT OF PELICAN SOUTH SHORE RESORTS ADDITION SHORE ALL LOT LINE BEING AN EXTENSION OF THE PREVIOUSLY PLATTED LINES. THE LOCATION OF THE ACTUAL HIGHWAY "B" IS NOT IN THE PLATTED AND THERE MAYBE A PORTION OF THE REPLAT THAT LIES SOUTHEASTERLY OF THE EXISTING HIGHWAY. THIS IS A MATTER THAT SHOULD BE INVESTIGATED BY A TITLE COMPANY FOR THE DETERMINATION AS TO OWNERSHIP SOUTHEASTERLY OF THE HIGHWAY.
