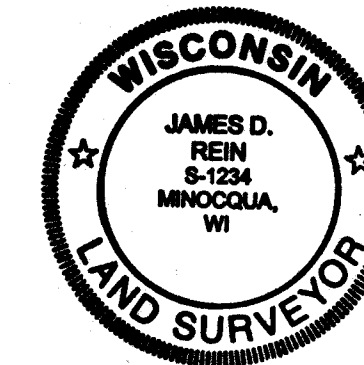

A parcel of land in the Northwest Quarter of the Southeast Quarter, Section 3, Township 38 North, Range 7 East, Lake Tomahawk Township, Oneida County, Wisconsin, being parcel "A" shown on Map No. 00-70 by Wilderness Surveying, Inc., dated October 23rd, 2000, more particularly described as follows:

Commencing at the south quarter corner of Section 3, marked by a brass capped iron pipe; thence North 01 degrees 28 minutes 36 seconds West for a distance of 1026.22 feet along the quarter line to the meander corner, marked by a brass capped iron pipe near the southerly shore of Eagle Lake; thence continuing along the quarter line North 01 degrees 30 minutes 49 seconds West for a distance of 500.34 feet to the place of beginning, being the meander corner where the west line of the Northwest Quarter of the Southeast Quarter intersects the northerly shore of Eagle Lake, marked by a brass capped iron pipe.

Thence North 01 degrees 22 minutes 59 seconds West for a distance of 1164.24 feet to the northwest corner of the Northwest Quarter of the Southeast Quarter, being the center quarter corner, marked by a brass capped iron pipe; thence South 89 degrees 48 minutes 19 seconds East for a distance of 300.11 feet along the north line of the Northwest Quarter of the Southeast Quarter; thence South 01 degrees 22 minutes 59 seconds East for a distance of 365.46 feet to an iron pipe; thence continuing South 01 degrees 22 minutes 59 seconds East for a distance of 415.19 feet to an iron pipe near the northerly shore of Eagle Lake; thence meandering along the lake South 75 degrees 40 minutes 48 seconds West for a distance of 243.12 feet; thence continuing along the lake South 09 degrees 43 minutes 57 seconds West for a distance of 327.04 feet to the place of beginning.

The above lateral lot lines extend to Eagle Lake, and include all lands lying between the meander line and the ordinary high water mark.

Said property contains 6.14 acres, more or less, including wetland area.

Commencing at the South quarter corner of Section 3, marked by a brass capped iron pipe; thence North 01 degrees 28 minutes 36 seconds West for a distance of 1026.22 feet along the quarter line to the meander corner, marked by a brass capped iron pipe near the southerly shore of Eagle Lake; thence continuing along the quarter line North 01 degrees 30 minutes 49 seconds West for a distance of 500.34 feet to the meander corner where the west line of the Northwest Quarter of the Southeast Quarter intersects the northerly shore of Eagle Lake, marked by a brass capped iron pipe; thence North 01 degrees 22 minutes 59 seconds West for a distance of 1164.24 feet to the north line corner of the Quarter of the Southeast Quarter, being the center quarter corner, marked by a brass capped iron pipe; thence South 89 degrees 48 minutes 19 seconds East for a distance of 300.11 feet along the north line of the Northwest Quarter of the Southeast Quarter to the place of beginning.

Thence continuing along the north line of the Northwest Quarter of the Southeast Quarter South 89 degrees 48 minutes 19 seconds East for a distance of 361.23 feet to the northwest corner of that parcel of land described in Volume 176, on page 240; thence South 01 degrees 06 minutes 20 seconds East for a distance of 669.84 feet to the southwest corner of said parcel of land described in Volume 176, on page 240; thence North 89 degrees 57 minutes 11 seconds East for a distance of 298.35 feet along the south line of said parcel of land described in Volume 176, on page 240 to an iron pipe; thence continuing North 89 degrees 57 minutes 11 seconds East for a distance of 358.47 feet to the southeast corner of said parcel of land described in Volume 176, on page 240, marked by an iron pipe on the east line of the Northwest Quarter of the Southeast Quarter; thence South 00 degrees 48 minutes 29 seconds East for a distance of 667.00 feet to the southeast corner of the Northwest Quarter of the Southeast Quarter, being the Southeast Sixteenth Corner, marked by a brass capped iron pipe; thence South 89 degrees 28 minutes 44 seconds West for a distance of 117.18 feet along the south line of the Northwest Quarter of the Southeast Quarter to the meander corner, marked by an iron pipe near the northeasterly shore of Eagle Lake; thence meandering along the lake North 38 degrees 10 minutes 39 seconds West for a distance of 321.73 feet; thence continuing along the lake North 87 degrees 09 minutes 02 seconds West for a distance of 402.46 feet; thence continuing along the lake North 46 degrees 53 minutes 29 seconds West for a distance of 417.13 feet to an iron pipe; thence North 01 degrees 22 minutes 59 seconds West for a distance of 415.19 feet to an iron pipe; thence continuing North 01 degrees 22 minutes 59 seconds West for a distance of 365.46 feet to the place of beginning.

The above lateral lot lines extend to Eagle Lake, and include all lands lying between the meander line and the ordinary high water mark.
