

Commencing at the southwest corner of Section 11, marked by an iron rod in the pavement of County Highway "L"; thence South 88 degrees 26 minutes 12 seconds East for a distance of 336.59 feet along the south line of Section 11 to the place of beginning, being the southeast corner of that parcel of land described in Document No. 243967, marked by a Bernsten survey marker nail in the pavement of

Thence continuing South 88 degrees 26 minutes 12 seconds East for a distance of 357.89 feet along the south line of Section 11 to a Bernsten survey marker nail in the pavement of Lakewood Drive; thence North 00 degrees 00 minutes 00 seconds East for a distance of 33.01 to an iron pipe on the northerly right of way line of Lakewood Drive; thence continuing North 00 degrees 00 minutes 00 seconds East for a distance of 1296.40 feet to an iron pipe on the north line of the Southwest Quarter of the Southwest Quarter; thence North 88 degrees 24 minutes 54 seconds West for a distance of 616.64 feet along the north line of the Southwest Quarter of the Southwest Quarter to an iron pipe on the easterly right of way line of County Highway "L"; thence South 00 degrees 53 minutes 54 seconds West for a distance of 1062.22 feet along the easterly right of way line of County Highway "L" to an extension of north line of that parcel of land described in Document No. 122877, marked by an iron pipe; thence South 88 degrees 34 minutes 13 seconds East for a distance of 171.02 feet to the northwest corner of that parcel of land described in Document No. 243967, marked by an iron pipe; thence South 88 degrees 26 minutes 12 seconds East for a distance of 100.00 feet to the northeast corner of said parcel of land described in Document No. 243967, marked by an iron pipe; thence South 00 degrees 56 minutes 07 seconds East for a distance of 234.63 feet along the east line of said parcel of land described in Document No. 243967 to an iron pipe on the northerly right of way line of Lakewood Drive; thence continuing South 00 degrees 56 minutes 07 seconds East for a distance of 33.03 feet to the place of beginning.

Thence continuing South 88 degrees 26 minutes 12 seconds East for a distance of 497.62 feet along the south line of Section 11 to southwest corner of that parcel of land described in Document No. 266586, marked by an iron pipe; thence North 00 degrees 53 minutes 01 seconds West for a distance of 350.00 feet to the northwest corner of said parcel of land described in Document No. 266586, marked by an iron pipe; thence South 88 degrees 26 minutes 12 seconds East for a distance of 145.00 feet to the northeast corner of said parcel of land described in Document No. 266586, marked by an iron pipe on the east line of the Southwest Quarter of the Southwest Quarter; thence North 00 degrees 53 minutes 01 seconds West for a distance of 979.90 feet to northeast corner of the of the Southwest Quarter of the Southwest Quarter, being the Southwest Sixteenth Corner, marked by an aluminum capped iron pipe; thence North 88 degrees 24 minutes 54 seconds West for a distance of 622.11 feet along the north line of the Southwest Quarter of the Southwest Quarter to an iron pipe, thence South 00 degrees 00 minutes 00 seconds East for a distance of 1296.40 feet to an iron pipe on the northerly right of way line of Lakewood Drive; thence continuing South 00 degrees 00 minutes 00 seconds East for a distance of 33.01 feet to the


Bearings Oneida County Grid, based on GPS survey data.
