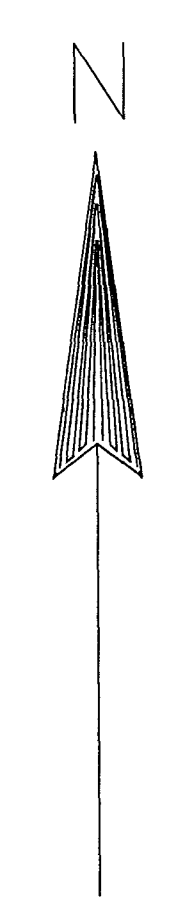
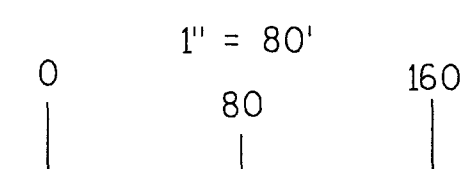


A Parcel of Land Located in

Parcel Description

Commencing at the West Quarter corner of Section 29, Town 37 North, Range 10 East, Township of Stella, Oneida County, Wisconsin, marked by an Oneida County Monument, said point also being the POINT OF BEGINNING;

thence along the West line of said section 29, N 0°22'57" W for a distance of 1321.29' to the Northwest corner of the SW 1/4 of the NW 1/4 of said section 29 marked with a 1 1/4" Iron Pipe; thence along the North line of said SW 1/4 of the NW 1/4, N 87°11'48" E for a distance of 475.28' to the Southwesterly edge of the Soo Line Railroad Right of Way, marked with a 1 1/4" Iron Pipe; thence along the Southwesterly edge of the Railroad Right of Way, S 69°59'52" E for a distance of 143.44' to a 1 1/4" Iron Pipe; thence leaving said Right of Way, parallel to the West line of said SW 1/4 of the NW 1/4, S 0°22'57" E for a distance of 1282.32' to the North line of Gov't Lot 4, marked with a 1 1/4" Iron Pipe; thence parallel to the West line of Gov't Lot 4, S 0°13'44" E for a distance of 849.99' to the Northerly edge of Camp Bryn Afon Rd., marked with a 1 1/4" Iron Pipe; thence along the Northerly edge of Camp Bryn Afon Rd., along a curve concave Northwesterly, with a radius of 500.43' and an arc length of 72.51', being subtended by chord bearing S 73°45'13" W and a length of 72.46' to a 1 1/4" Iron Pipe; thence along a curve concave Northerly, with a radius of 294.82' and an arc length of 179.02', being subtended by a chord bearing N 86°52'59" W and a length of 176.38' to a 1 1/4" Iron Pipe; thence N 69°47'04" W for a distance of 216.07' to a 1 1/4" Iron Pipe; thence along a curve concave Northeasterly, with a radius of 170.31' and an arc length of 82.13', being subtended by a chord bearing N 55°52'38" W and a length of 81.34' to a 1 1/4" Iron Pipe; thence continuing along the Northeasterly edge of Moens Lake Drive N 42°03'44" W for a distance of 140.75' to the west line of Said Gov't Lot 4, marked with a 1 1/4" Iron Pipe; thence leaving the edge of Moens Lake Drive, along the West line of said Gov't Lot 4, N 0°13'44" W for a distance of 29.46' to a 2" Iron Pipe; thence continuing along the West line of said Gov't Lot 4, N 0°13'44" W for a distance of 639.51' to the POINT OF BEGINNING.
