

LOCATED IN THE NE 1/4 - SE 1/4 & THE SE 1/4 - SE 1/4, SECTION 4, T36N, R09E, TOWN OF PELICAN, ONEIDA COUNTY, WISCONSIN

PROPERTY DESCRIPTION

A parcel of land located in the NE 1/4 - SE 1/4 and the SE 1/4 - SE 1/4, Section 4, T36N, R09E, Town of Pelican, Oneida County, Wisconsin, described as follows:

Commencing at the East 1/4 corner of said section 4; thence S18°26'05"E, a distance of 450.16 feet to an iron pipe; thence S89°14'34"W, a distance of 543.50 feet to an iron pipe and point of beginning. Thence S02°05'35"W, a distance of 434.84 feet to an iron pipe; thence S28°15'24"W, a distance of 690.43 feet to an iron pipe; thence S89°06'05"W, a distance of 356.71 feet to an iron pipe on the easterly right-of-way line of North Faust Lake Road; thence along said right-of-way line, N08°48'05"W, a distance of 106.76 feet to an iron pipe; thence leaving said right-of-way line, N89°06'05"E, a distance of 220.02 feet to an iron pipe; thence N00°47'07"E, a distance of 206.68 feet to an iron pipe; thence N00°32'39"E, a distance of 67.09 feet to an iron pipe; thence S81°43'21"W, a distance of 85.28 feet to an iron pipe; thence N08°47'17"W, a distance of 391.06 feet to an iron pipe; thence S89°39'38"E, a distance of 211.93 feet to an iron pipe; thence N08°19'16"W, a distance of 285.54 feet to an iron pipe; thence N89°14'34"E, a distance of 466.17 feet to the point of beginning. Said parcel contains 10.41 acres. Subject to and including easements, restrictions, reservations and rights of way of record or in use. Also including a 66 foot wide easement for vehicular ingress-egress and utilities for future owners of said parcel, their successors, heirs and assigns described as follows:

A 66' wide easement located in the NE 1/4 - SE 1/4 and the SE 1/4 - SE 1/4, Section 4, T36N, R09E, Town of Pelican, Oneida County, Wisconsin, the centerline of said easement described as follows: Commencing at the East 1/4 corner of said Section 4; thence S26°32'45"W, a distance of 1474.00 feet to the point of beginning; thence S08°21'27"W, a distance of 76.68 feet to a point; thence S20°15'51"W, a distance of 80.86 feet to a point; thence S34°45'08"W, a distance of 71.34 feet to a point; thence S45°16'39"W, a distance of 73.55 feet to a point; thence S57°36'39"W, a distance of 71.67 feet to a point; thence S63°54'10"W, a distance of 235.93 feet to a point on the easterly right-of-way line of North Faust Lake Road and terminus of said easement.


