

All bearings are referenced to the West line of the SW 1/4 of Section 23 recorded as bearing N01°18'55"E on Plat of Survey O.C.L.I.O. Map Number C-894

## **NOTES:**

- 1. The lot lines of "Parcel A" and "Parcel B" were flagged at the time of survey.
- 2. Legal descriptions were provided to the client on separate sheets.
- 3. Wetlands were observed on the property surveyed.
- 4. The existing monumented right—of—way of Stella Lake Road is from Plat of Survey dated July 6, 1988 O.C.L.I.O. Map Number C-894 as shown hereon. In some areas the existing traveled way doesn't match the recorded centerline per said Plat of Survey as shown on the map
- 5. POINT "A" was established at the position called for by Volume 586, Page 48 and Volume 815, Page 123 of Oneida County Records and data from Oneida County Land Information Office Map Number C-894.
- 6. POINT "B" was a found iron lying \$03'28'32"W, 201.84 feet from POINT "A" and had some remnants of flagging running Westerly from it. It appears that the Northerly/Easterly adjoining landowner assumed this was the property corner and constructed the logging road running Northwesterly as shown hereon. As this is an indication of use of a portion of Parcel "A" by others, our client is advised to seek the advise of legal counsel on this issue.




