SURVEYOR'S CERTIFICATE

I, KEITH M. HALL, HEREBY CERTIFY THAT I HAVE, AT THE REQUEST OF GEORGE SAVAGE, OF RHINELANDER, WISCONSIN, SURVEYED THE EAST AND WEST QUARTER LINE OF SECTION 14, TOWNSHIP 36 NORTH, RANGE 9 EAST, WISCONSIN, IN 1945. THAT I FOUND THE ORIGINAL EAST 1/4TH CORNER OF THIS SECTION, PERPETUATED SAME WITH AN IRON PIPE AND MARKED ONE NEW BEARING TREE - A WHITE PINE 9 INCH BEARING SOUTH 14° WEST 18. FEET. GOVT. STUMPS ABOUT GONE EXCEPT FOR PORTIONS OF IRON MARKED FACINGS. D.H. VAUGHAN'S B.T. - A WHITE PINE STUMP 14 INCH BEARING NORTH 5°-30' WEST 24.4 FEET - MARKED IN 1912 IS IN GOOD CONDITION (SEE VAUGHAN NOTES IN RE: SECTION 13 - PAGE 66 OF ONEIDA COUNTY RECORD). THAT I RAN THENCE WEST TO V.M. MAINE'S WEST 1/4TH CORNER (WHICH HE HAD ESTABLISHED EARLIER BY RUNNING THE WEST LINE OF THIS SECTION), THAT I ESTABLISHED THE MEANDER CORNER ON THE WEST SHORE OF LAKE GEORGE ON THE AFORESAID QUARTER LINE BETWEEN GOV. LOTS 3 AND 4 AS HEREON SHOWN. THAT I HAVE, FROM TIME TO TIME SINCE 1945, STAKED OUT AND DESCRIBED THE VARIOUS PARCELS IN GOV. LOT 3, SECURING SAME TO SAID QUARTER LINE, MAKING THE PLACE OF BEGINNING OF EACH PARCEL A STATED DISTANCE FROM THE AFORESAID MEANDER CORNER, WITH THE EXCEPTION OF THE LESTER PARCEL, WHICH BEGINS AT THE WEST 1/4 TH. CORNER AND INCLUDES ALSO A PART OF GOV. LOT 4. THAT THE MAP HEREON DRAWN WAS PREPARED BY ME AND IS TO THE BEST OF MY KNOWLEDGE AND BELIEF A CORRECT REPRESENTATION OF MY SURVEY.
