

PARCEL - E (Map No. 10-39)

A parcel of land located in the Northwest Quarter of the Northeast Quarter and the Northeast Quarter of the Northwest Quarter, Section 15, Township 36 North, Range 6 East, Town of Nokomis, Oneida County, Wisconsin, being "Parcel E" shown on Map No. 10-39 by Wilderness Surveying, Inc., dated March 3, 2011 and revised November 9, 2011, more particularly described as follows:

Beginning at the quarter corner common to Section 10 and Section 15, marked by a capped aluminum monument; thence North 88 degrees 46 minutes 54 seconds East for a distance of 1337.09 feet along the north line of Section 15 to the East Sixteenth Corner, marked by an aluminum capped iron pipe; thence South 00 degrees 30 minutes 48 seconds West for a distance of 938.02 feet along the east line of the Northwest Quarter of the Northeast Quarter to an iron pipe at the northeast corner of that parcel of land recorded on Document No. 680165; thence South 89 degrees 07 minutes 51 seconds West for a distance of 214.74 feet along the northerly line of that parcel of land recorded on Document No. 680165 to an iron pipe; thence continuing along the northerly line of that parcel of land recorded on Document No. 680165, South 49 degrees 58 minutes 24 seconds West for a distance of 156.53 feet to an iron pipe; thence continuing along the northerly line of that parcel of land recorded on Document No. 680165, South 65 degrees 14 minutes 05 seconds West for a distance of 174.62 feet to an iron pipe; thence along the westerly line of that parcel of land recorded on Document No. 680165, South 08 degrees 03 minutes 04 seconds East for a distance of 99.45 feet to an iron pipe on the south line of the Northwest Quarter of the Northeast Quarter; thence South 88 degrees 44 minutes 50 seconds West for a distance of 33.23 feet along the south line of the Northwest Quarter to an iron pipe; thence continuing South 88 degrees 44 minutes 50 seconds West for a distance of 687.62 feet to the Center-North Sixteenth Corner, marked by an iron pipe; thence North 00 degrees 30 minutes 48 seconds East for a distance of 938.02 feet along the north line of the Northwest Quarter of the Northeast Quarter to an iron pipe; thence North 75 degrees 31 minutes 38 seconds West for a distance of 277.33 feet to an iron pipe; thence North 67 degrees 58 minutes 29 seconds West for a distance of 107.75 feet to an iron pipe; thence North 44 degrees 45 minutes 25 seconds West for a distance of 210.42 feet to an iron pipe; thence North 00 degrees 30 minutes 48 seconds East for a distance of 938.02 feet along the north line of Section 15 to the place of beginning.

A strip of land thirty three (33) feet wide for the purpose of an access and utility easement, previously described as over the existing road, located in the Northwest Quarter of the Northeast Quarter and in the Northwest Quarter of the Northeast Quarter, Section 15, Township 36 North, Range 6 East, Town of Nokomis, Oneida County, Wisconsin, being "33' Wide Access & Utility Easement" shown on Map No. 10-39 by Wilderness Surveying, Inc., dated March 3, 2011 and revised November 9, 2011, the southerly and easterly line of which is more particularly described as follows:

Commencing at the northeast corner of Section 15, marked by an iron rod; thence South 88 degrees 46 minutes 54 seconds West for a distance of 103.08 feet along the north line of Section 15 to an iron pipe at an intersection with the westerly right of way line of County Highway "L"; thence South 00 degrees 31 minutes 48 seconds West for a distance of 990.71 feet along said westerly right of way line to the place of beginning of the southerly and easterly line of said strip of land, marked by an iron pipe.

Thence South 89 degrees 07 minutes 51 seconds West for a distance of 1227.76 feet to an iron pipe on the line common to the Northwest Quarter of the Northeast Quarter and the Northwest Quarter of the Northeast Quarter; thence continuing South 89 degrees 07 minutes 51 seconds West for a distance of 214.74 feet to an iron pipe; thence South 49 degrees 58 minutes 24 seconds West for a distance of 156.53 feet to an iron pipe; thence South 65 degrees 14 minutes 05 seconds West for a distance of 174.62 feet to an iron pipe; thence South 08 degrees 03 minutes 04 seconds East for a distance of 99.45 feet to an iron pipe on the south line of the Northwest Quarter of the Northeast Quarter and there terminating.

Thence North 44 degrees 45 minutes 25 seconds West for a distance of 210.42 feet to an iron pipe; thence North 00 degrees 30 minutes 48 seconds East for a distance of 938.02 feet to an iron pipe; thence North 75 degrees 31 minutes 38 seconds West for a distance of 277.33 feet to an iron pipe; thence North 67 degrees 58 minutes 29 seconds West for a distance of 107.75 feet to an iron pipe; thence North 24 degrees 41 minutes 30 seconds West for a distance of 324.77 feet to the north line of Section 15 and there terminating.

The northerly and easterly line of the above described strip of land lengthens or shortens to begin on the northerly line of said "33' Wide Access & Utility Easement" (Document No. 680165) and terminate on the north line of Section 15.

Together with and subject to covenants, easements, and restrictions of record.

PARCEL - F (Map No. 10-39)

A parcel of land located in the Northwest Quarter of the Northwest Quarter, Section 15, Township 36 North, Range 6 East, Town of Nokomis, Oneida County, Wisconsin, being "Parcel F" shown on Map No. 10-39 by Wilderness Surveying, Inc., dated March 3, 2011 and revised November 9, 2011, more particularly described as follows:

Commencing at the quarter corner common to Section 10 and Section 15, marked by a capped aluminum monument; thence South 88 degrees 46 minutes 54 seconds West for a distance of 397.33 feet along the north line of Section 15 to the place of beginning, marked by an iron pipe.

Together with an access and utility easement described as follows:

A strip of land thirty three (33) feet wide for the purpose of an access and utility easement, previously described as over the existing road, located in the Northwest Quarter of the Northeast Quarter and in the Northwest Quarter of the Northeast Quarter, Section 15, Township 36 North, Range 6 East, Town of Nokomis, Oneida County, Wisconsin, being "33' Wide Access & Utility Easement" (Document No. 680165) shown on Map No. 10-39 by Wilderness Surveying, Inc., dated March 3, 2011 and revised November 9, 2011, the southerly and easterly line of which is more particularly described as follows:

Thence North 44 degrees 45 minutes 25 seconds West for a distance of 210.42 feet to an iron pipe; thence North 00 degrees 30 minutes 48 seconds East for a distance of 938.02 feet to an iron pipe; thence North 75 degrees 31 minutes 38 seconds West for a distance of 277.33 feet to an iron pipe; thence North 67 degrees 58 minutes 29 seconds West for a distance of 107.75 feet to an iron pipe; thence North 24 degrees 41 minutes 30 seconds West for a distance of 324.77 feet to the north line of Section 15 and there terminating.

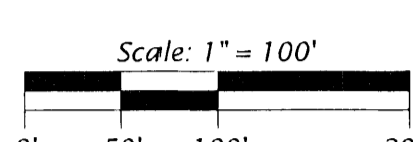

Said property contains 37.89 acres.

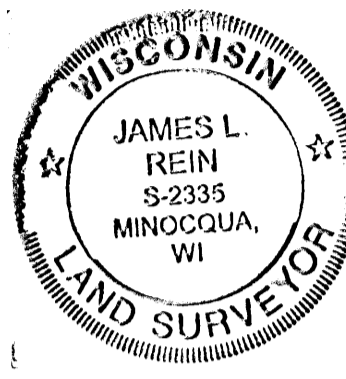
Bearings Oneida County Grid, based on GPS survey data, referenced to the north line of the NE 1/4, Section 15, bearing S 88°16'54"W

Monument sizes are outside diameter dimension. Other corner monuments are as noted.

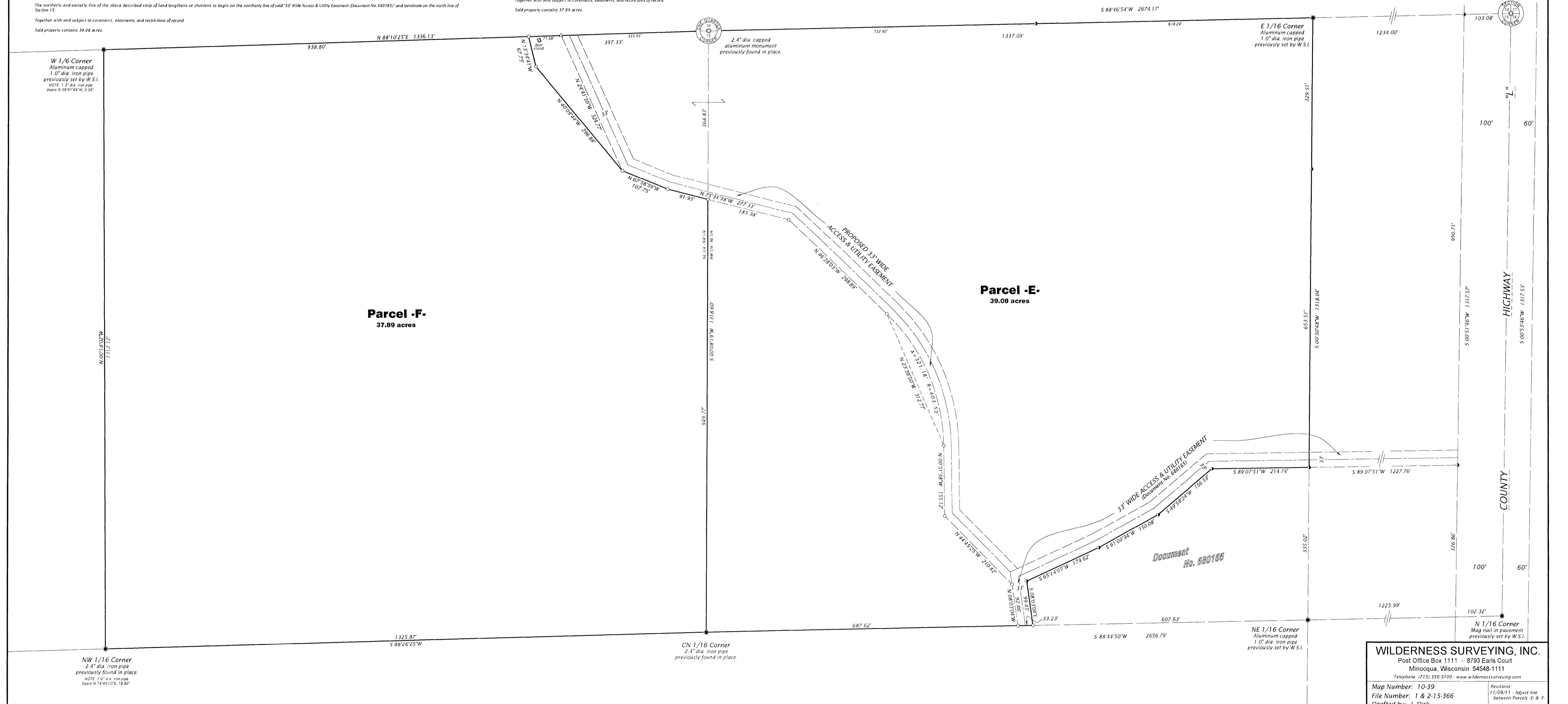


Part of the
