Commencing at the southwest corner of Section 31, Town 37 North Range 10 East; thence N 22°01'47" E, a distance of 3476.88 feet to the southwest corner of lands described in Document Number 707731 as recorded and the POINT OF BEGINNING; thence N 36°16'06" W, a distance of 213.77 feet (recorded as N 36°10'00" W, 214.00 feet) to a point near the south shore of Third Lake; thence N 41°53'25" E, along a meander line a distance of 100.06 feet (recorded as N 41°47'00" E, 100.00 feet); thence S 38°20'09" E, leaving said meander line, a distance of 259.60 feet (recorded as S 38°16'00" E, 259.60 feet); thence S 66°54'34" W a distance of 110.20 feet (recorded as S 66°44'00" W, 110.10 feet) to the POINT OF BEGINNING.


Said Parcel is contains 0.63 acres of land more or less including lands lying between the described meander line, the shore of Third Lake and the lateral lot lines extended.




