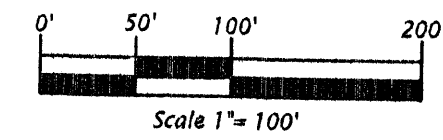
Commencing at the southwest corner of Section 34, marked by an aluminum monument; thence N89°01'02"E 672.94 feet along the south line of Section 34 to the place of beginning, marked by an iron pipe.

Thence continuing N89°01'02"E 656.91 feet to the southeast corner of the Southwest Quarter of the Southwest Quarter, being the West Sixteenth Corner marked by an iron pipe; thence N10°54'22"W 1071.75 feet along the east line of the Southwest Quarter of the Southwest Quarter to an iron rod on the south right of way line of County Trunk Highway "C"; thence along said south right of way line S84°58'48"W 692.01 feet to an iron pipe; thence S13°08'24"E 450.76 feet to an iron pipe; thence S13°15'01"E 579.57 feet to the place of beginning.

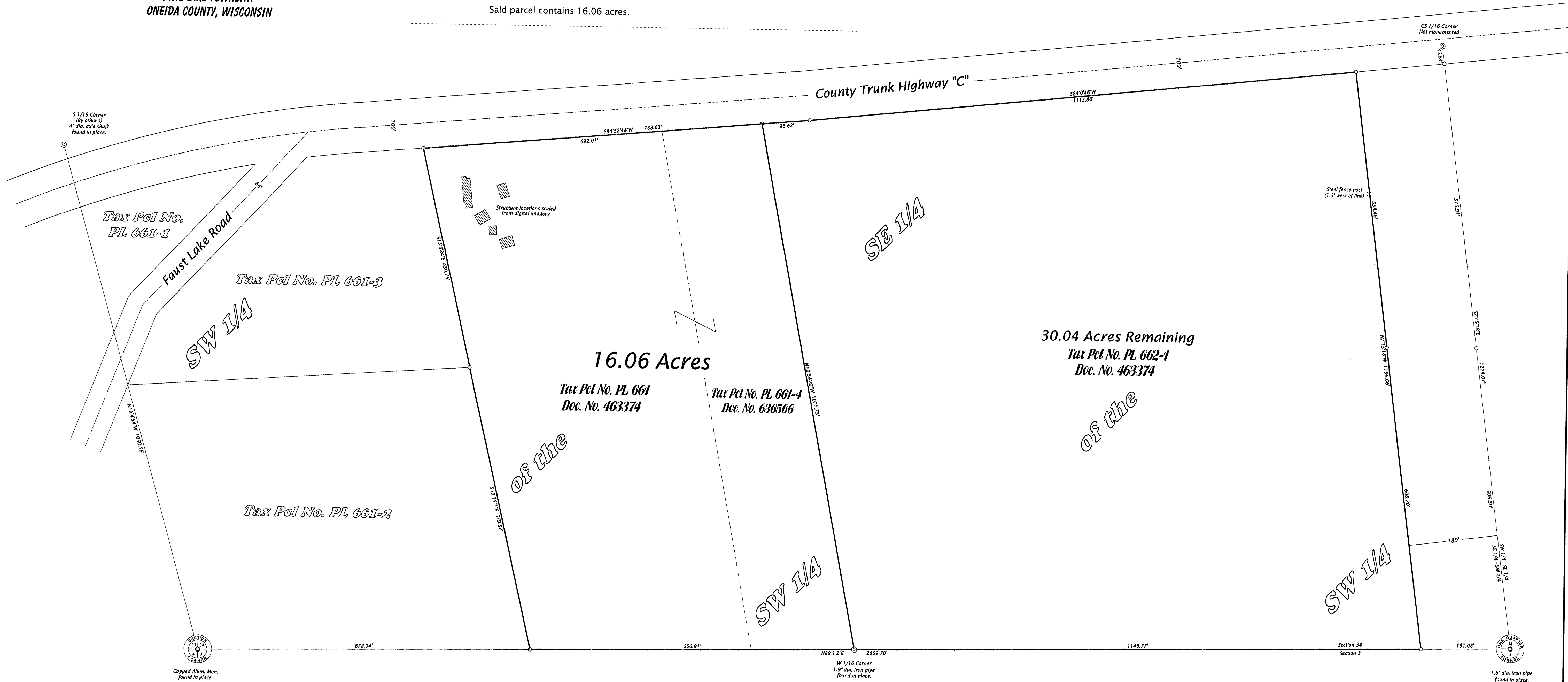
