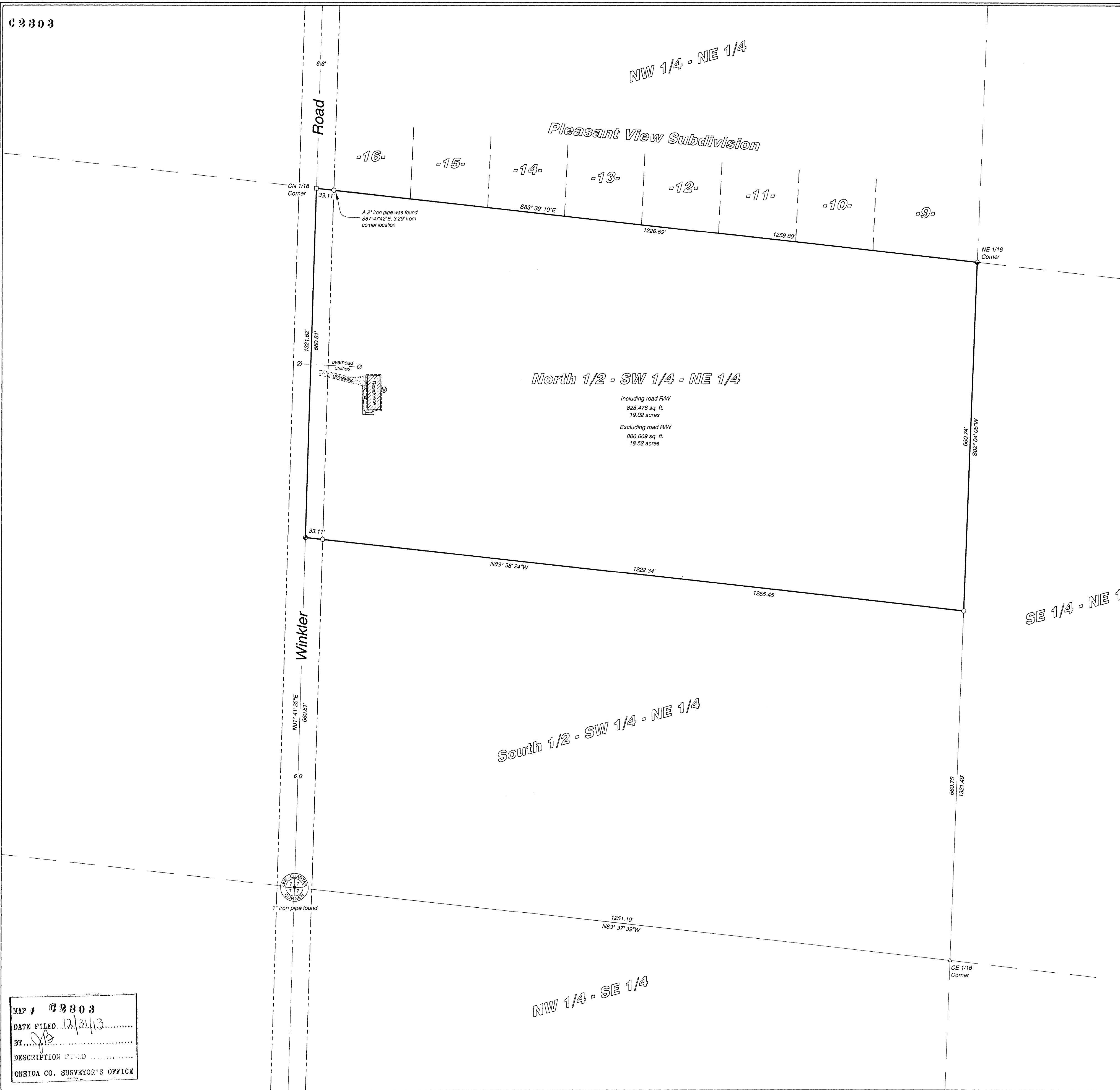


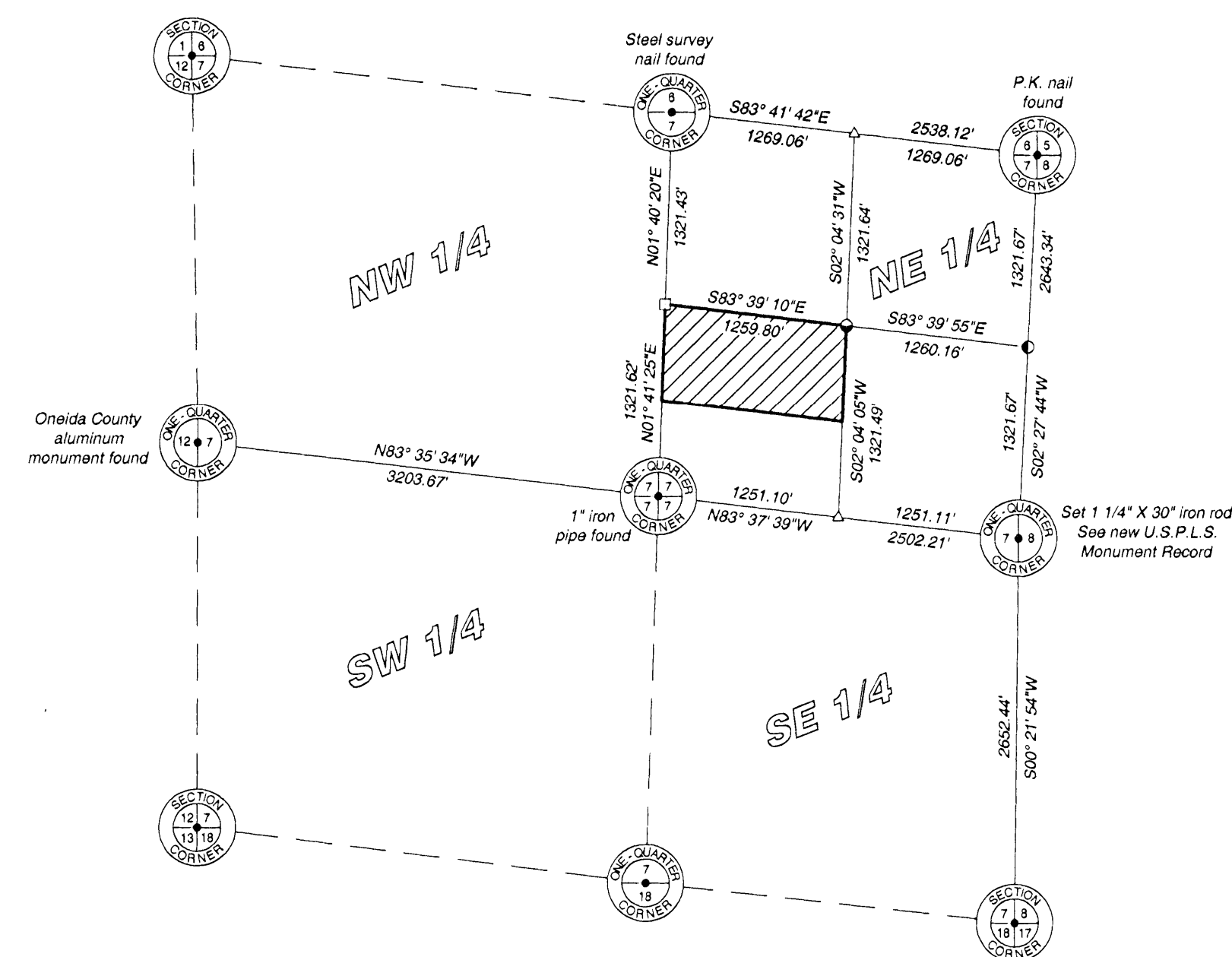

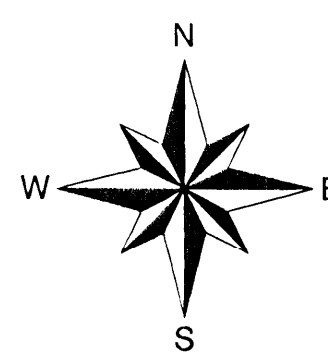

Section Summary

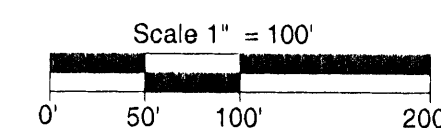

Legal Description

The North half of the Southwest one-quarter of the Northeast one-quarter of Section 7, Township 38 North, Range 11 East, Three Lakes Township, Oneida County, Wisconsin, more particularly described as follows:

Commencing at the north one-quarter corner of said Section 7 marked by a steel survey nail; thence along the west line of the Northwest one-quarter of the Northeast one-quarter of said Section 7 S01°40'20"W for a distance of 1321.43 feet to a railroad spike at the northwest corner of said Southwest one-quarter of the Northeast one-quarter and the PLACE OF BEGINNING. Thence along the north line of said Southwest one-quarter of the Northeast one-quarter S83°39'10"E for a distance of 1259.80 feet to an iron pipe at the northeast corner of the Southwest one-quarter of the Northeast one-quarter, thence along the east line of the Southwest one-quarter of the Northeast one-quarter S02°04'05"W for a distance of 660.74 feet to an iron pipe; thence N83°38'24"W for a distance of 1255.45 feet to a mag nail on the west line of said Southwest one-quarter of the Northeast one-quarter; thence along said west line N01°41'25"E for a distance of 660.81 feet to the PLACE OF BEGINNING.
