Beginning at the center | corner of Section 29, marked by an iron pipe, witnessed by a 12' Oak bearing N4°W, 14.2 feet, a 5" White Pine bearing S22°E, 19.8 feet and a 13" Oak bearing S30°W, 38.8 feet, thence S89°52'E, 1414.7 feet to a 1/8th corner, marked by an iron pipe, witnessed by a 7" White Birch bearing N88°E, 16.2 feet and a 14" White Birch bearing S38°E, 26.1 feet, thence S2°13'E, 1305.2 feet to a 1/16th corner, marked by an iron pipe, watnessed by a 6" Maple bearing S88°W, 72.0 feet and a 5" Maple bearing N45°W. 8.1 feet, thence N89°53'W, 1397.7 feet to a 1/8th corner, marked by an iron pipe, witnessed by a 15" White Pine bearing S66°E, 29.3 feet and an 8" Poplar bearing N1°E, 18 7 feet, thence N2°58'W, 1306.4 feet to the place of beginning.
