DESCRIPTION

A parcel of land being part of the NE 1/4 of the SW 1/4, and the SE 1/4 of the SW 1/4, Section 21, Township 39 North, Range 6 East, Town of Minocqua, Oneida County, Wisconsin, more particularly described as follows:

Beginning at the northwesterly corner of Lot 17 of Fisherman's Cove Addition To Lakes In The Woods Plat, marked by a 1-1/4" dia. iron rod; thence N0°11'17"E (solar bearing) along the westerly line of said NE1/4 - SW1/4, a distance of 870.18 feet to the center west 1/16 corner, marked by a 2" dia. iron pipe; thence S87°06'19"E along the northerly line of said NE1/4 - SW1/4, a distance of 1326.36 feet to the center of said section 21, marked by a 5" square concrete monument; thence S0°12'59"W along the easterly line of said NE1/4 - SW1/4, a distance of 1296.06 feet to a 1-1/4" dia. iron rod on the northwesterly right of way line of Streater Road; thence S36°08'55"W along said line, 58.19 feet to a 1-1/4" dia. iron rod on the northerly line of said Plat; thence N29°23'16"W along said line, 327.21 feet to a 1-1/4" dia. iron rod; thence S87°02'17"W along said line, 291.66 feet to a 1-1/4" dia. iron rod; thence N71°55'32"W along said line, 242.50 feet to a 1-1/4" dia. iron rod; thence N71°57'34"W along said line, 639.27 feet to the point of beginning.

Described parcel of land contains 31.72 acres.

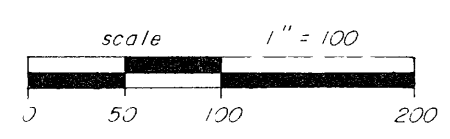
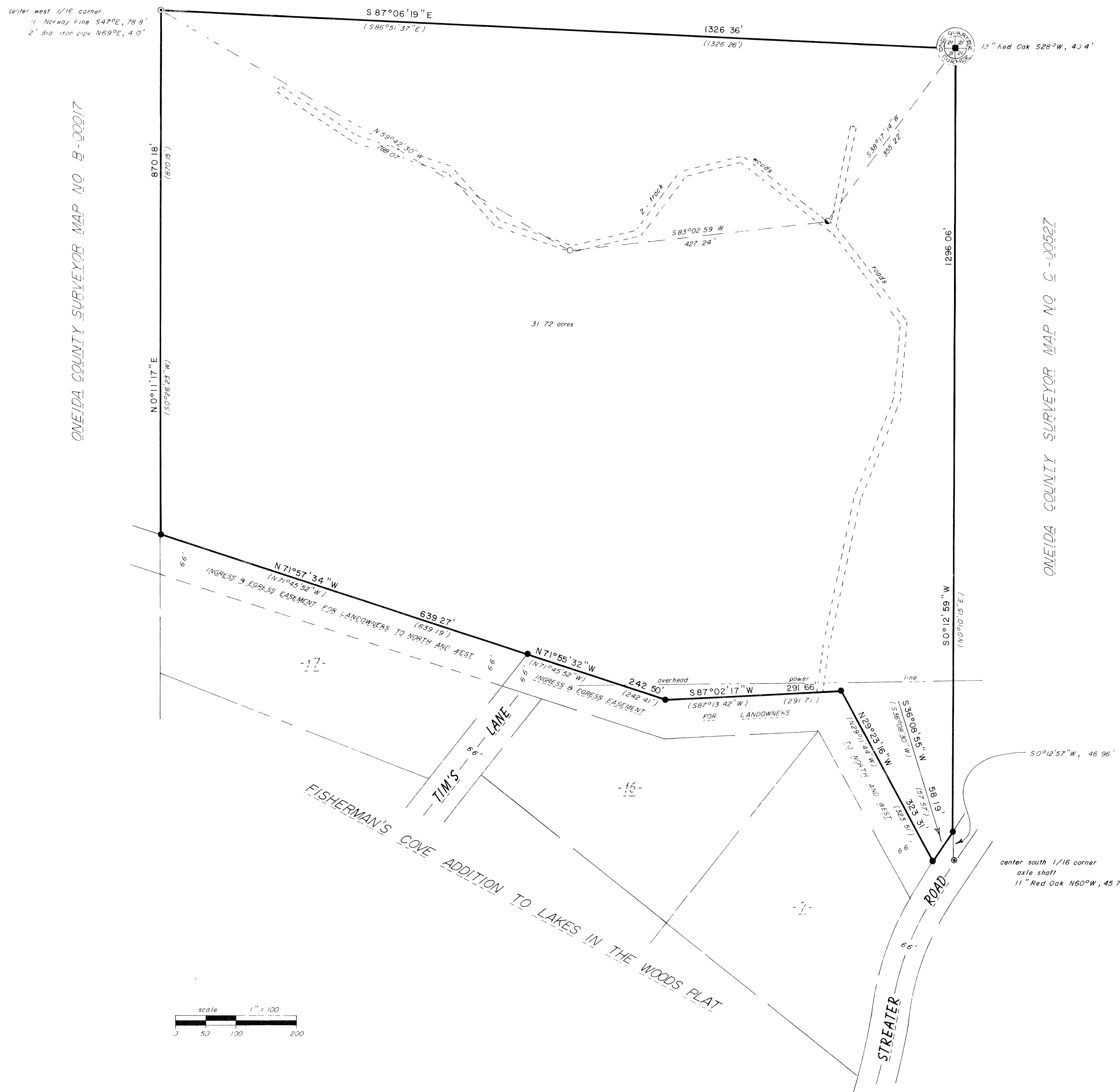
