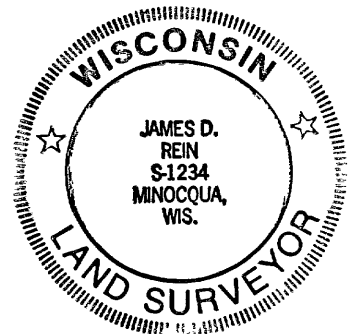

MUSSA PARCEL

A parcel of land in Government Lot 1, Section 10, Township 37 North, Range 7 East, Cassian Township, Oneida County, Wisconsin, being "PARCEL 4" shown on Map No. 91-42 by Wilderness Surveying, Inc., dated August 15th, 1991, more particularly described as follows:

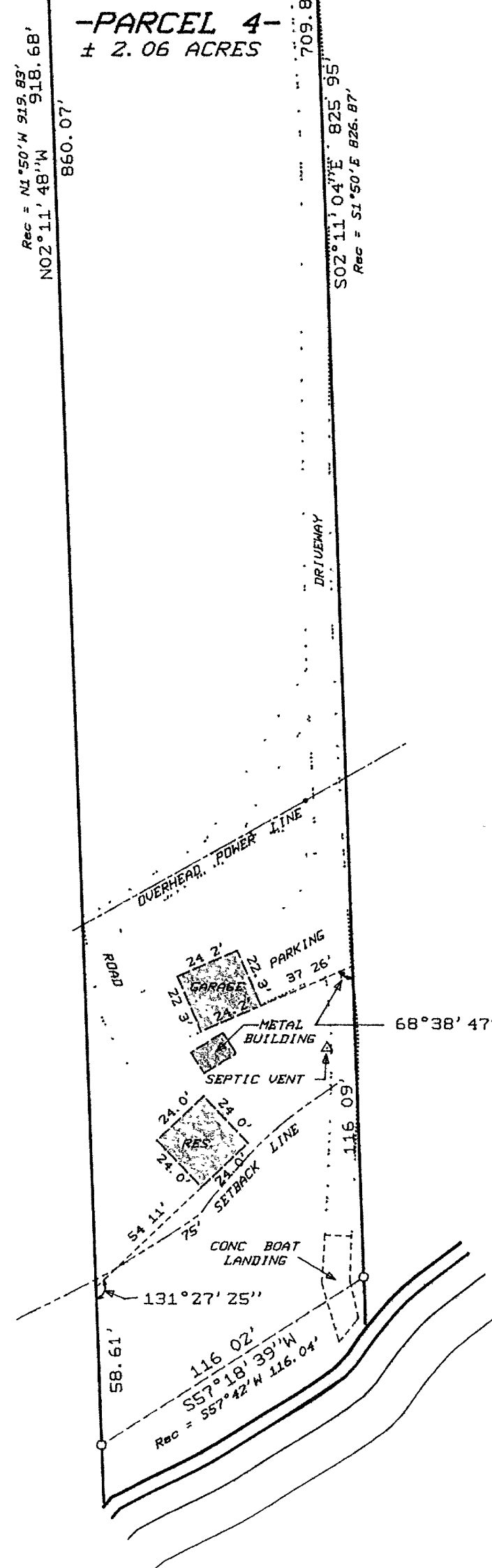
Commencing at the corner common to Sections 2, 3, 10 and 11, marked by a brass capped iron pipe; thence North 88 degrees 06 minutes 09 seconds West for a distance of 755.40 feet; thence South 00 degrees 07 minutes 51 seconds West for a distance of 683.68 feet to an iron pipe on the southerly right of way line of North Alva Road; thence South 81 degrees 47 minutes 15 seconds East for a distance of 100.77 feet along said right of way line; thence continuing along said right of way line South 73 degrees 30 minutes 55 seconds East for a distance of 52.11 feet along said right of way line to the place of beginning, marked by an iron pipe.

Thence continuing South 73 degrees 30 minutes 55 seconds East for a distance of 105.71 feet along said right of line to an iron pipe; thence South 02 degrees 11 minutes 04 seconds East for a distance of 825.95 feet to an iron pipe near the northerly shore of Alva Lake, thence meandering along the lake South 57 degrees 18 minutes 39 seconds West for a distance of 116.02 feet to an iron pipe; thence North 02 degrees 11 minutes 48 seconds West for a distance of 918.68 feet to the place of beginning.

Including also all lands lying between the meander line and the shore of Alva Lake

Together with and subject to covenants, easements, and restrictions of record.
