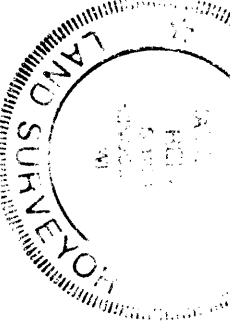

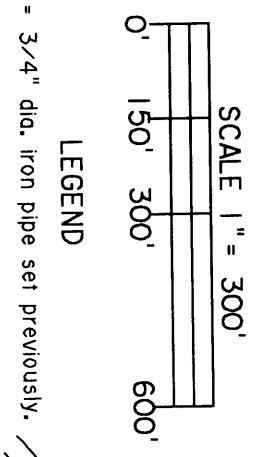

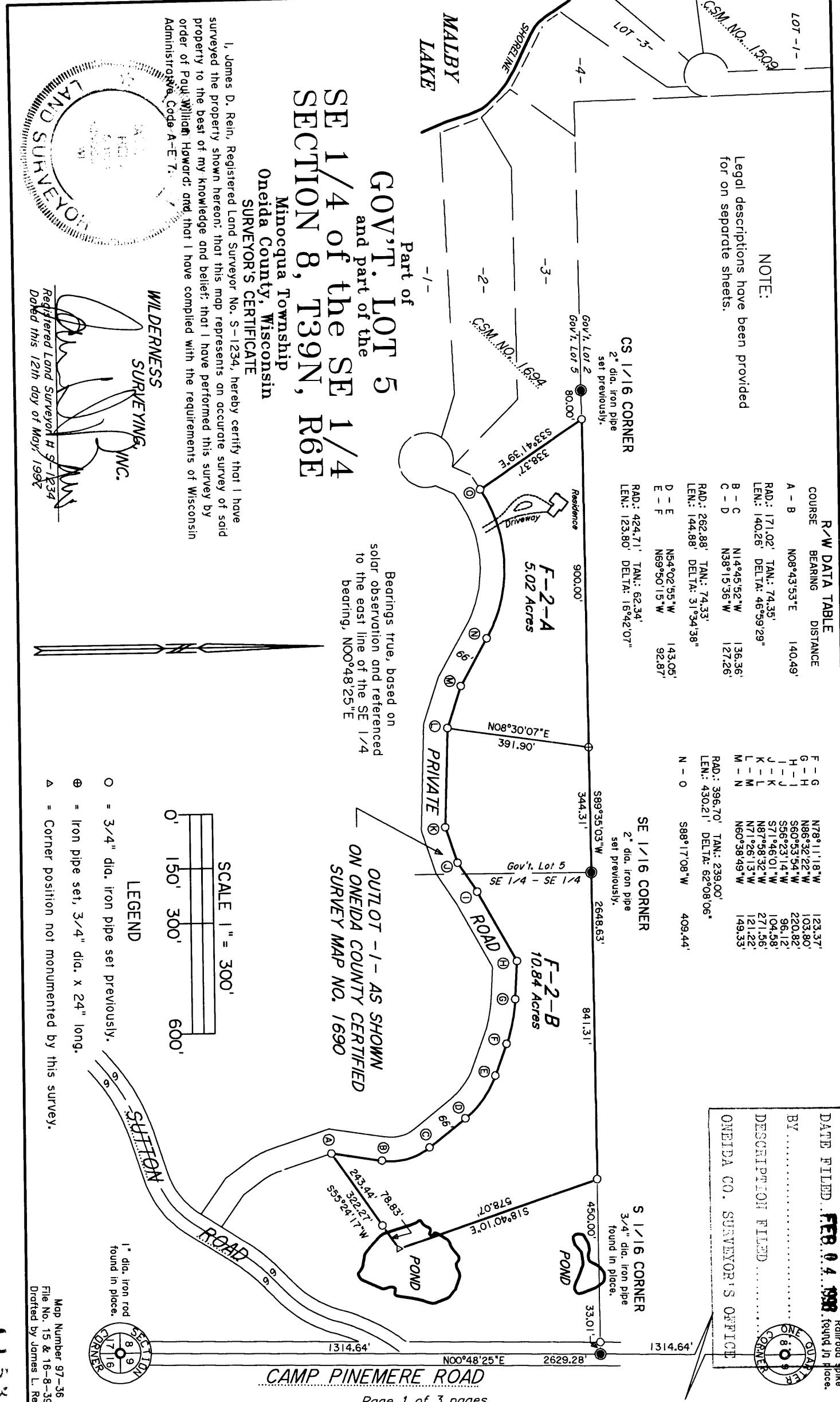

Parcel F-2-A (Map No. 97-36)

A parcel of land in Government Lot 5, Section 8, Township 39 North, Range 6 East, Minocqua Township, Oneida County, Wisconsin, being parcel "F-2-A" shown on Map No. 97-36 by Wilderness Surveying, Inc., dated May 12th, 1997, more particularly described as follows:

Commencing at the southeast corner of said Section 8, marked by an iron rod in the centerline of Camp Pinemere Road; thence North 00 degrees 48 minutes 25 seconds East for a distance of 1314.64 feet along the east line of Section 8 to the northeast corner of the Southeast Quarter of the Southeast Quarter, being the South Sixteenth Corner, marked by an iron pipe; thence South 89 degrees 35 minutes 03 seconds West for a distance of 1324.32 feet to the Southeast Sixteenth Corner, marked by an iron pipe; thence South 89 degrees 35 minutes 03 seconds West for a distance of 344.31 feet along the north line of the Government Lot 5 to the place of beginning, marked by an iron pipe.

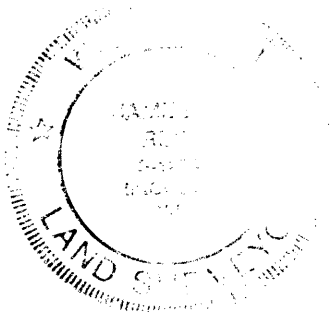



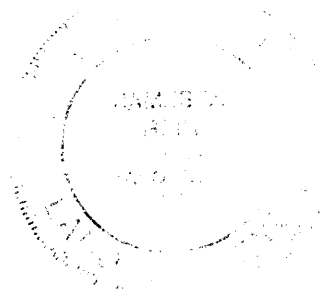
Commencing at the southeast corner of said Section 8, marked by an iron rod in the centerline of Camp Pinemere Road; thence North 00 degrees 48 minutes 25 seconds East for a distance of 1314.64 feet along the east line of Section 8 to the northeast corner of the Southeast Quarter of the Southeast Quarter, being the South Sixteenth Corner, marked by an iron pipe; thence South 89 degrees 35 minutes 03 seconds West for a distance of 483.01 feet along the north line of the Southeast Quarter of the Southeast Quarter to the place of beginning, marked by an iron pipe.
