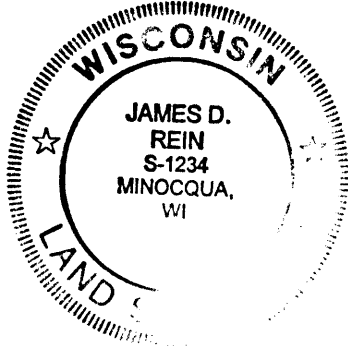

**PROPOSED UTILITY EASEMENT**

A strip of land twenty (20) feet in width for purpose of a utility easement in the Southwest Quarter of the Southwest Quarter, Section 1, and in the Southeast Quarter of the Southeast Quarter, Section 2, Township 38 North, Range 6 East, Hazelhurst Township, Oneida County, Wisconsin, being shown on Map No. 01-110UE by Wilderness Surveying, Inc., dated October 11, 2001, the centerline of which is more particularly described as follows:

Commencing at the west quarter corner of said Section 1, marked by an iron pipe; thence South 14 degrees 20 minutes 53 seconds East for a distance of 1980.17 feet to an iron pipe on the east line of that parcel of land described in Volume 843, on pages 682 and 683; thence South 00 degrees 11 minutes 17 seconds East for a distance of 534.96 feet along the east line of said parcel of land described in Volume 843 on pages 682 and 683 to the place of beginning of said easement.

Thence South 84 degrees 30 minutes 20 seconds West for a distance of 145.19 feet; thence South 87 degrees 06 minutes 18 seconds West for a distance of 125.33 feet; thence North 82 degrees 35 minutes 22 seconds West for a distance of 121.58 feet; thence South 51 degrees 04 minutes 01 seconds West for a distance of 185.06 feet; thence North 84 degrees 53 minutes 51 seconds West for a distance of 255 feet more or less to an existing power pole and there terminating.

The side lines lengthen or shorten to being on the east line of that parcel of land described in Volume 843, on pages 682 and 683, and terminate perpendicular to the existing power pole.

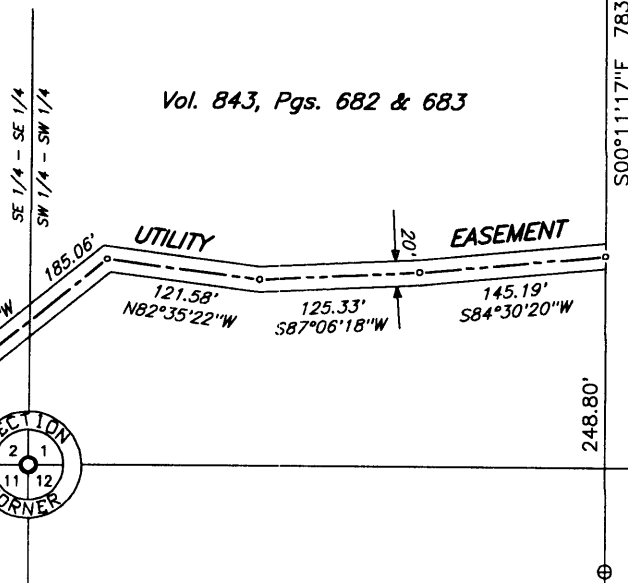

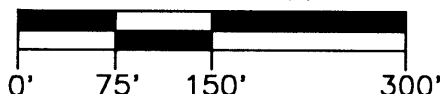
