COMMENCING AT A FOUND B.L.M. WITNESS CORNER ON THE SOUTH LINE OF THE SE 1/4 OF THE SE 1/4 OF SECTION 16; THENCE N 12°49'53" E, 195.68 FEET TO A 1" IRON PIPE FOUND MARKING THE SOUTHEAST CORNER OF PARCEL 6 AND THE POINT OF BEGINNING; THENCE N 17°14'50" E, 200.34 FEET TO A 3/4" REBAR SET AT THE BASE OF A FOUND DISTURBED 1" IRON PIPE MARKING THE NORTHEAST CORNER OF PARCEL 6; THENCE N 68°08'40" W, 348.98 FEET TO A 3/4" REBAR SET REPLACING A FOUND 1/2" IRON PIPE MARKING THE NORTHWEST CORNER OF PARCEL 6 AND THE EAST LINE OF A TOWN ROAD; THENCE S 14°36'29" W, 197.40 FEET ALONG THE EAST LINE OF A TOWN ROAD TO A 1" IRON PIPE FOUND MARKING THE SOUTHWEST CORNER OF PARCEL 6; THENCE S 13°54'13" W, 6.50 FEET ALONG THE EAST LINE OF A TOWN ROAD TO A 1" IRON PIPE FOUND MARKING THE NORTHWEST CORNER OF A PARCEL OF LAND DESCRIBED IN VOLUME 189 OF RECORDS, PAGE 108, DOCUMENT 152077; THENCE S 67°25'36" E, 340.37 FEET TO THE NORTHEAST CORNER OF A PARCEL OF LAND DESCRIBED IN VOLUME 189 OF RECORDS, PAGE 108, DOCUMENT 152077; THENCE N 12°58'18" E, 6.92 FEET TO THE POINT OF BEGINNING.

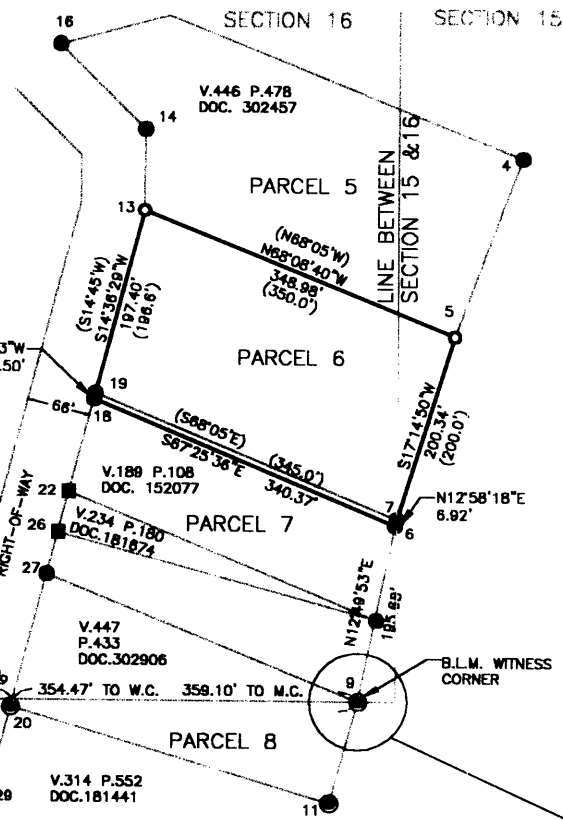

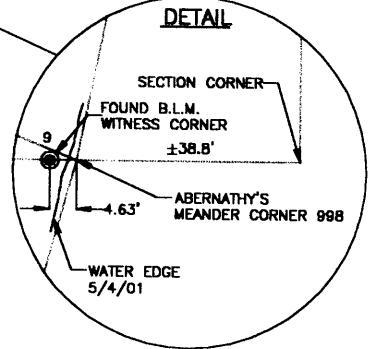

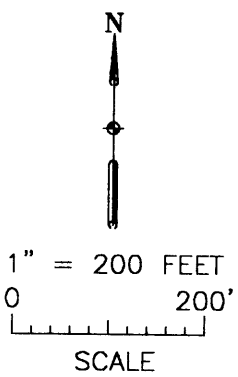
