

<p>Describe survey landmark found or reset and origin if known, such as being a 1/16 corner, called for in a deed or shown on a record land survey map or plat; also note location by Govt Lot, 1/4 section or other PLSS subdivisional tract.</p> <p>I checked this corner at the request of Oneida County Surveyor, which was originally tied by Glenn Barker/RLS 1682 per filed U.S. Public Land Survey Monument Record dated 9/6/94, as this corner was more recently located by GPS control survey per Oneida County survey records.</p> <p>I found standard aluminum corner monument undisturbed and all of Barker's record BT's OK except that his NW Pj is now dead.</p> <p>I also found a standard white poly 'T' marker post disturbed which I reset 6" North of corner monument.
