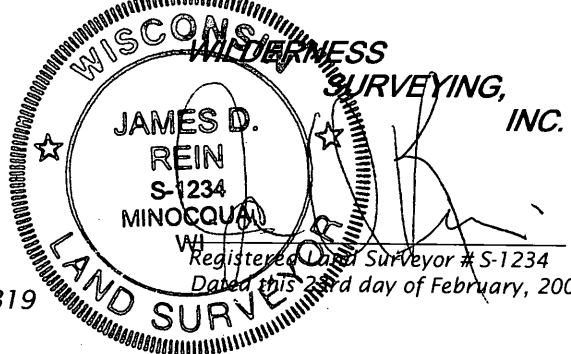

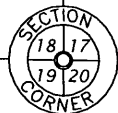

bearing S 00°08'24"E

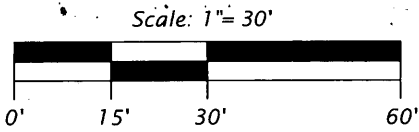
Brass capped 2.0" dia.

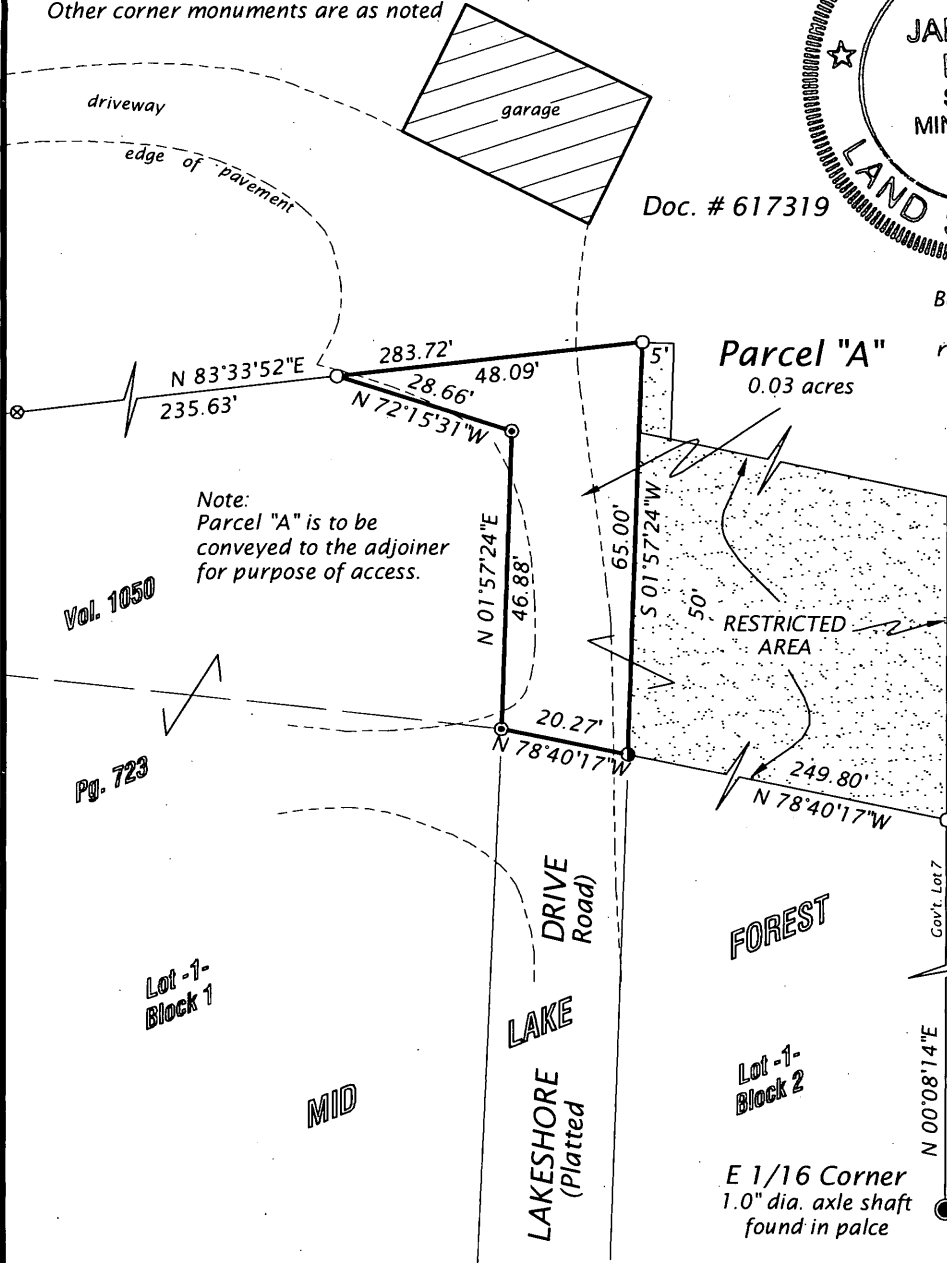
1.0" dia. axle shaft

A parcel of land in the unplatted part of Government Lot 7, Section 18, Township 39 North, Range 7 East, Woodruff Township, Oneida County Wisconsin, being parcel "A" shown on Map No. 05-275A by Wilderness Surveying, Inc., dated February 23, 2006, more particularly described as follows:

Commencing at the southeast corner of said Section 18, marked by an axle shaft; thence North 89 degrees 19 minutes 36 seconds West for a distance of 1326.65 feet along the south line of Section 18 to the southeast corner of Government Lot 7, being the east sixteenth corner, marked by an axle shaft; thence North 00 degrees 08 minutes 14 seconds East for a distance of 617.41 feet along the east line of Government Lot 7 to an iron pipe; thence North 78 degrees 40 minutes 17 seconds West for a distance of 249.80 feet to the place of beginning, marked by an iron pipe at the northwest corner of Lot 1, Block 2 in the plat of Mid Lake Forest.

Thence continuing North 78 degrees 40 minutes 17 seconds West for a distance of 20.27 feet to the northeast corner of Lot 1, Block 1 in the plat of Mid Lake Forest, marked by a masonry nail in the asphalt pavement; thence North 01 degrees 57 minutes 24 seconds East for a distance of 46.88 feet to a masonry nail; thence North 72 degrees 15 minutes 31 seconds West for a distance of 28.66 feet to an iron pipe; thence North 83 degrees 33 minutes 52 seconds East for a distance of 48.09 feet to an iron pipe; thence South 01 degrees 57 minutes 24 seconds West for a distance of 65.00 feet to the place of beginning.
