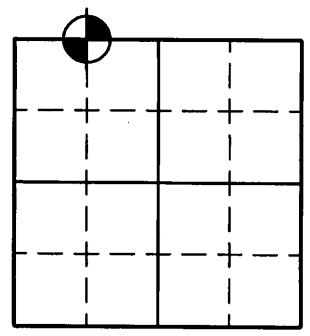

July 29, 2004 - We found a 1/2" Iron Rod approximately 5' South of the centerline of Camp Four Road at the NE Corner of the NW 1/4-NW 1/4. This is called out as a 1/2" by 18" Rerod in blacktop road and marked as the W 1/16 Corner on Plat of Survey by Jean Resvick dated 12/1/1988 Oneida County Land Information Map Number C-595.

August 12, 2005 - After road construction we reset a P.K. Nail at this location.

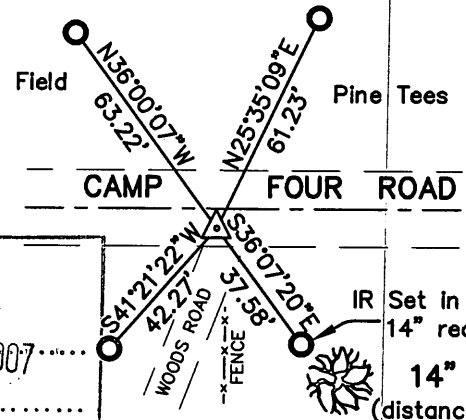

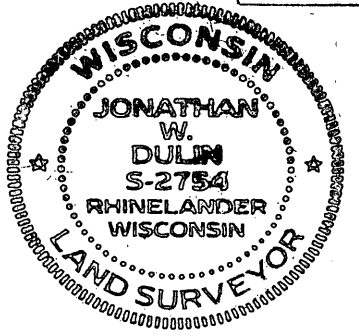
