

May 15, 2006 - We found a P.K. nail 3' South of the centerline of County Highway "Q". We also found a 1-1/2" iron pipe with a 2" brass cap stamped "EC 1/16 W.C." In 1977 Philip T. Hansen found a 4" cedar post, squared and scribed, EC 1/16 S13 W.C. and replaced it with a 1-1/2" iron pipe with a brass cap. He also recovered 2 bearing trees for the witness corner - See U.S.P.L.S. Monument Record by Philip T. Hansen dated 09/03/1975.

November 7, 2007- After road construction was complete we rechecked the ties and set a Survey nail stamped "Survey Marker" Show approximate location of survey landmark on this Section diagram:


