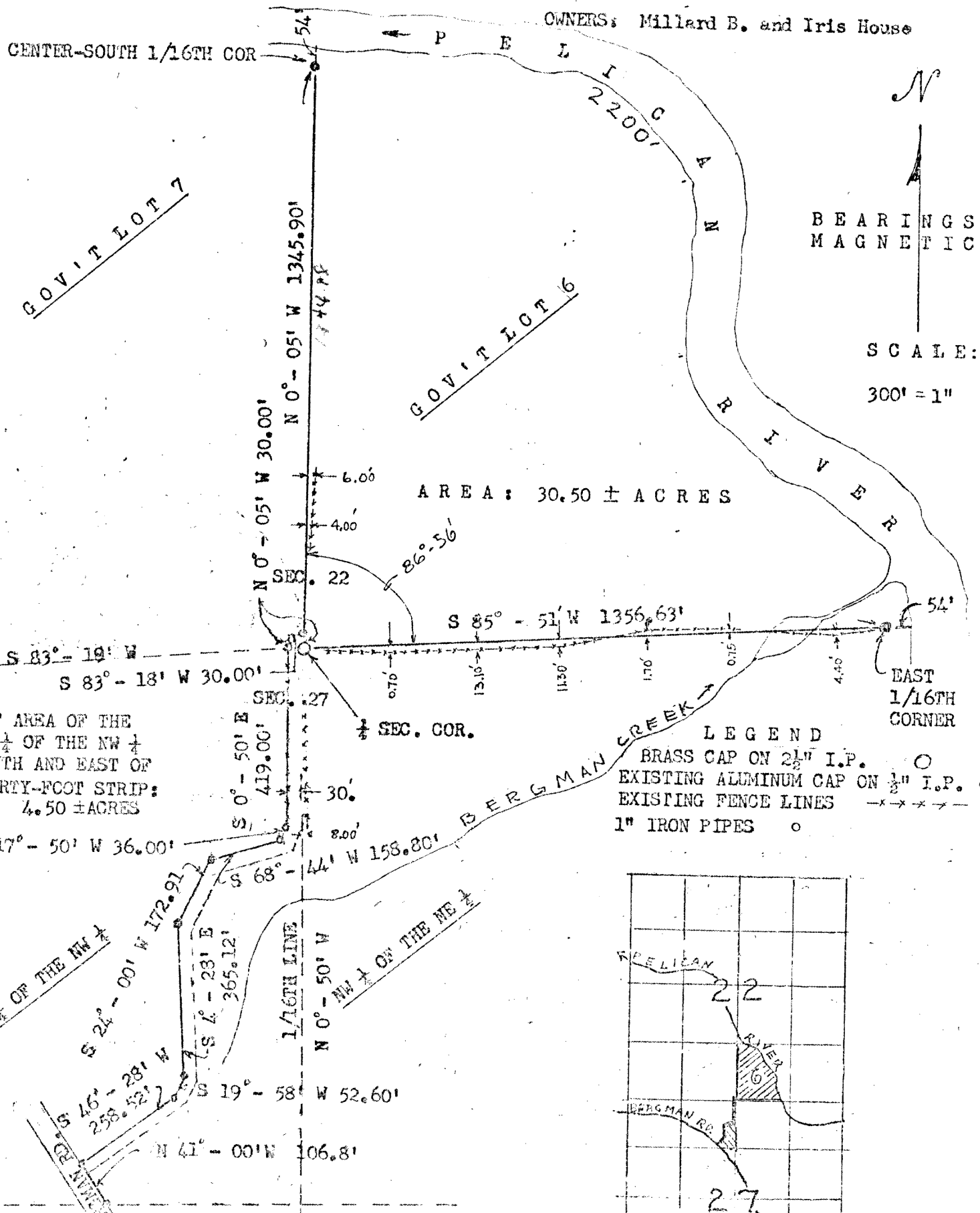


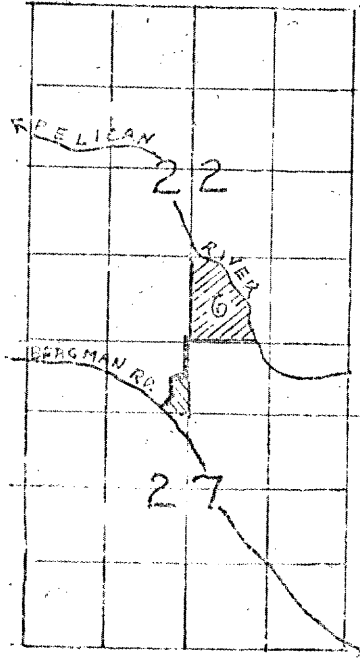

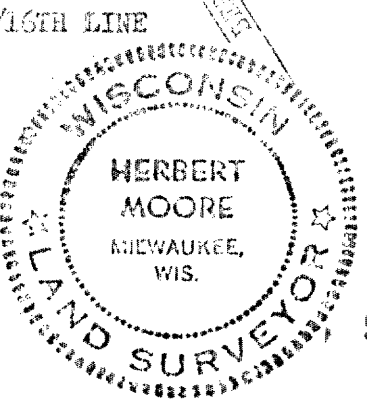
LOCATION PLAN

DESCRIPTION

Gov't Lot 6, Sec. 22, T 36 N, R 9 E commencing at the South $\frac{1}{4}$ corner of the section; thence N $0^{\circ}-05'$ W 1345.90 feet to the center-south 1/16th Corner; thence N $0^{\circ}-05'$ W 54.00 feet to the low water mark on the south bank of the Pelican River; thence easterly and southerly along the low water line of the river 2200 feet more or less to the south line of the section; thence S $85^{\circ}-51'$ W 54.00 feet to the East 1/16th corner; thence S $85^{\circ}-51'$ W 1356.63 feet to the point of beginning, and including for ingress to and egress from Bergman Road a corner of Gov't Lot 7 having measurements of thirty feet by thirty feet, located in the southeasterly corner thereof; and also a strip of land thirty feet wide in the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Sec. 27, and located at the easterly boundary thereof and extending S $0^{\circ}-50'$ E 419.00 feet; and thence proceeding along the northerly and westerly boundary of an existing road S $17^{\circ}-50'$ W 36.00 feet; thence S $63^{\circ}-44'$ W 158.80 feet; thence S $24^{\circ}-00'$ W 172.90 feet; thence S $4^{\circ}-28'$ E 365.12 feet; thence S $19^{\circ}-58'$ W 52.60 feet; thence S $46^{\circ}-28'$ W 258.52 feet to a point on the easterly boundary of Bergman Road, which point is N $41^{\circ}-00'$ W and 106.80 feet from the 1/16th line.
