EXTERIOR DESCRIPTION

Part of Government Lot 5, Section 9, Township 38 North, Range 6 East, Town of Hazelhurst, Oneida County, Wisconsin as shown on a survey map by McMullen & Associates, Incorporated of Minocqua, Wisconsin dated the 28th day of December, 2013 with a job number of 214004 and more particularly described as follows:

Commencing at the meander corner common to sections 9 and 10 on the northerly shore of Upper Kaubashine Lake marked by a capped aluminum monument; thence North 44° 50' 19" West, a distance of 774.45 feet to a 1.900" iron pipe, said point being the POINT OF BEGINNING;

Thence South 23° 13' 27" West, a distance of 388.94 feet to a 1.900" iron pipe near the shore of said lake; thence meandering along said lake shore North 53° 16' 54" West, a distance of 96.21 feet to a 2.375" iron pipe; thence leaving said meander line North 37° 32' 39" East, a distance of 378.24 feet to the POINT OF BEGINNING.

Said described tract containing 19,402 Sq. Feet or 0.45 Acres, more or less.

Subject to any easements, restrictions, or rights of way of record or of use.

Including all those lands lying between the above described meander line and the water's edge of Upper Kaubashine Lake.
