SPECIAL AGREEMENT

WHEREAS, Oneida County has purchased certain right of way for highway purposes according to the right of way plat prepared by the Wisconsin Highway Commission for Federal Aid Project No. 380-A Reopened, the said right of way lying in the west one-half (W $\frac{1}{2}$) of the northeast quarter (NE $\frac{1}{4}$) of Section eighteen (18) and the west one-half (W $\frac{1}{2}$) of the southeast quarter (SE $\frac{1}{4}$) of Section seven (7), Township thirty-five (35) North, Range eleven (11) East, Town of Schoepke, Oneida County; and

WHEREAS, the owner of the above descriptions according to the records in the office of Register of Deeds in the Court House of Oneida County is shown to be Mrs. Hannah Jansen; and

WHEREAS, Oneida County has dealt with Mrs. Hannah Jansen for the above described right of way; and

WHEREAS, according to the above mentioned Wisconsin Highway Commission right of way plat, the quarter corner between said Sections seven (7) and eighteen (18) is shown to be approximately four hundred thirty (430) feet west of the center line of State Trunk Highway No. 26; and

WHEREAS, there is a dispute as to the location of said quarter corner, claims being advanced that said quarter corner is located approximately three hundred sixty-three (363) feet east of the center line of said State Trunk Highway No. 26; and

WHEREAS, in case said quarter corner is located three hundred sixty-three (363) feet east of the center line of State Trunk Highway No. 26 the said highway and the right of way therefore will then be located wholly or in part in the east one-half (E $\frac{1}{2}$) of the northwest quarter (NW $\frac{1}{4}$) and the northeast quarter (NE $\frac{1}{4}$) of the southwest quarter (SW $\frac{1}{4}$) of said Section eighteen (18);

NOW THEREFORE, we, the undersigned owners of the southeast quarter (SE $\frac{1}{4}$) of the northwest quarter (NW $\frac{1}{4}$) and a small portion of the northeast quarter (NE $\frac{1}{4}$) of the southwest quarter (SW $\frac{1}{4}$) of said Section eighteen (18), do hereby acknowledge receipt of One Dollar (\$1.00) and other valuable considerations in consideration of which we hereby release all right of way necessary for the construction of Federal Aid Project 380-A Reopened across the southeast quarter (SE $\frac{1}{4}$) of the northwest quarter (NW $\frac{1}{4}$) and the northeast quarter (NE $\frac{1}{4}$) of the southwest quarter (SW $\frac{1}{4}$) of said Section eighteen (18) and we hereby further release all claims for any additional compensation for the above described right of way across the above described parcels of land.
