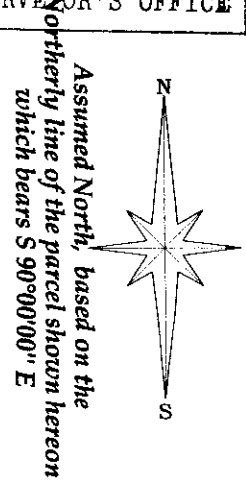
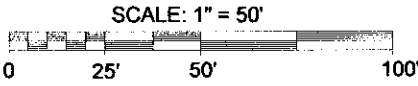

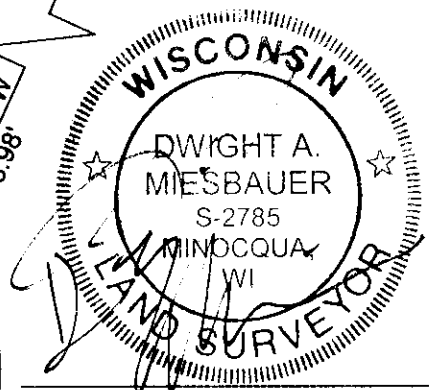

Description

Part of Government Lot 2, Section 30, Township 39 North, Range 11 East, town of Three Lakes, Oneida County, Wisconsin shown on a survey map by Survey North, LLC of Wisconsin with a Job No. of 13R001 dated the 18th Day of January, 2013 being previously described in Document No. 707501 recorded at the Oneida County Register of Deeds and more particularly described as follows:

Commencing at the Meander Corner between Section 19 and Section 30 marked by an Oneida County Aluminum Monument near the Westerly shore of Planting Ground Lake; thence South 24° 34' 39" West (Assumed North, based on the Northerly line of the parcel described herein which bears South 90° 00' 00" East), a distance of 838.98 feet to a 1.3" Iron Pipe near the shore of said lake, said point being the POINT OF BEGINNING;

Thence meandering along said lake shore South 9° 14' 57" West, a distance of 184.11 feet to a point; thence continuing said meander South 89° 12' 07" West, a distance of 171.00 feet to a 1.3" Iron Pipe; thence leaving said meander North 0° 13' 56" East, a distance of 184.10 feet to a 1.3" Iron Pipe; thence South 90° 00' 00" East, a distance of 199.83 feet to the POINT OF BEGINNING.

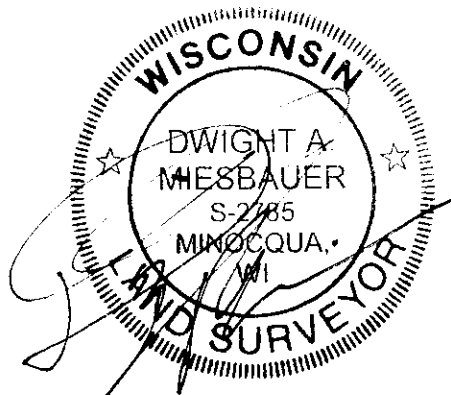
