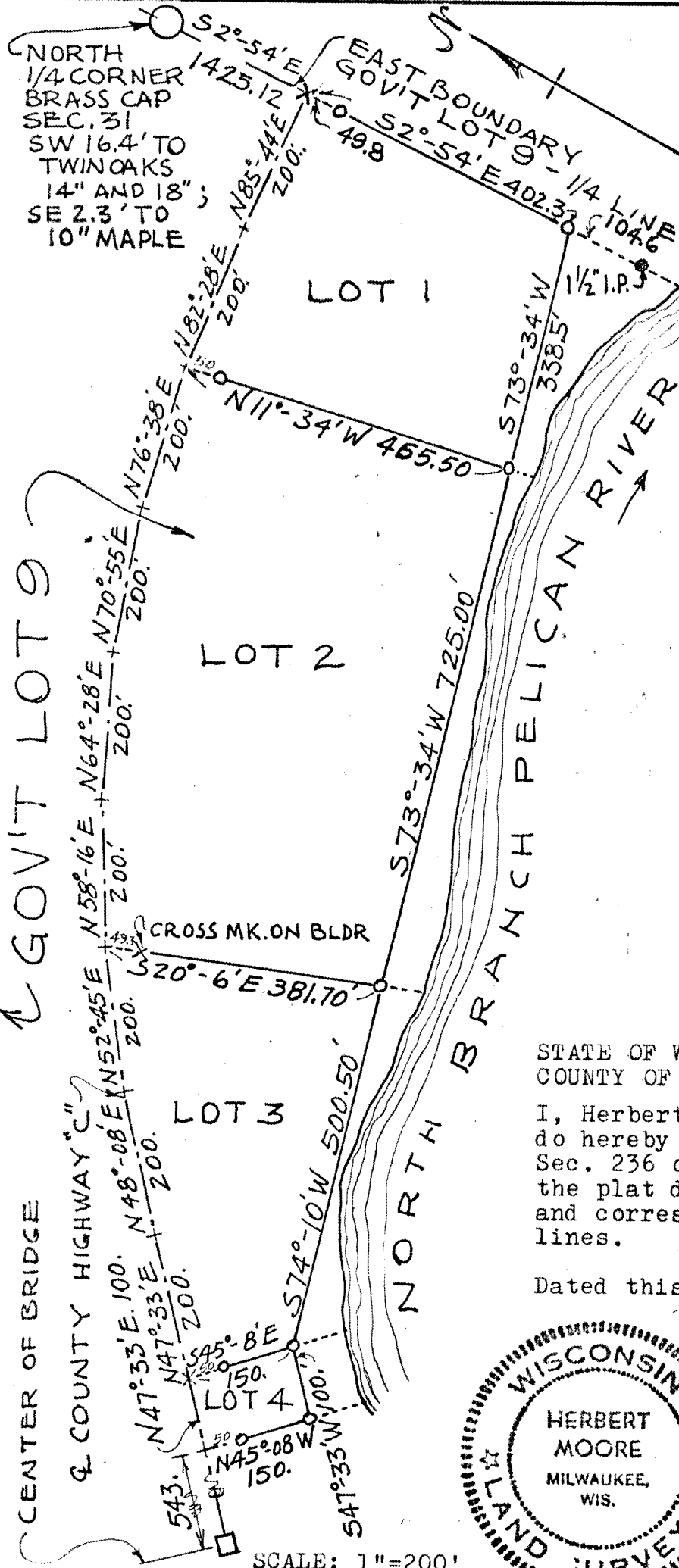

E.; thence S 2°- 54' E along the 1/4 line 1425.12 feet to the center line of the County Highway "C", which is the point of beginning; thence continuing S 2°- 54' E along the 1/4 line 402.30 feet to a point; thence S 73°- 34' W 338.50 feet to a point; thence continuing S 73°- 34' W 725.00 feet to a point; thence S 74°- 10' W 500.50 feet to a point; thence S 47°- 33' W 100.00 feet to a point; thence N 45°- 08' W 150.00 feet to a point on the center line of the county highway; thence along the center line of the highway N 47°- 33' E 100.00 feet to a point; thence continuing along the center line of the highway N 47°- 33' E 200.00 feet to a point; thence N 48°- 08' E 200.00 feet to a point; thence N 52°- 45' E 200.00 feet to a point; thence N 58°- 16' E 200.00 feet to a point; thence N 64°- 28' E 200.00 feet to a point; thence N 70°- 55' E 200.00 feet to a point; thence N 76°- 38' E 200.00 feet to a point; thence N 82°- 28' E 200.00 feet to a point; thence N 85°- 44' E 200.00 feet to the point of beginning, and all lands to the shoreline of the North Branch of the Pelican River lying between the easterly and westerly lines thereof extended, and reserving the northwesterly fifty feet thereof for the public highway.
