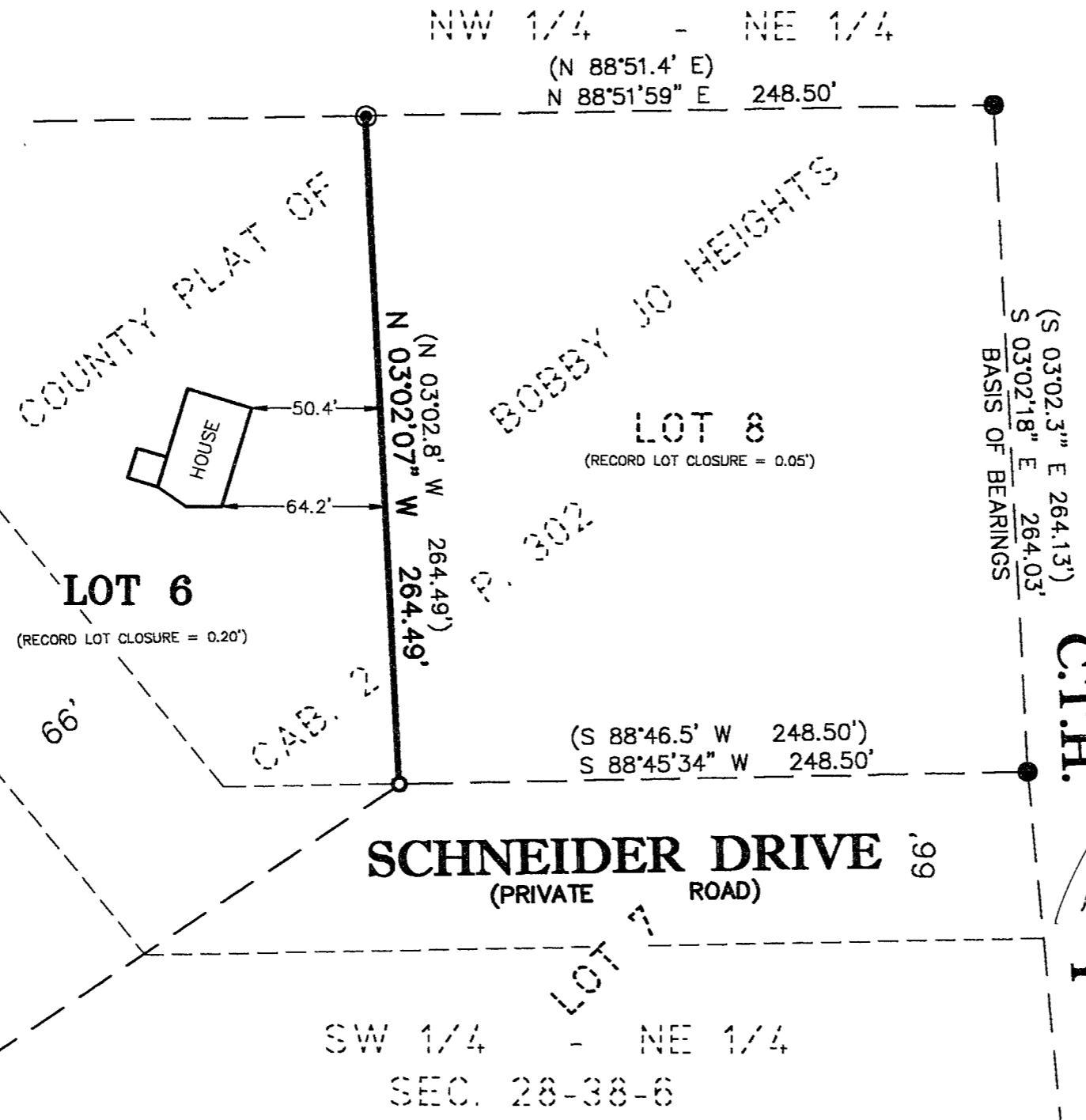
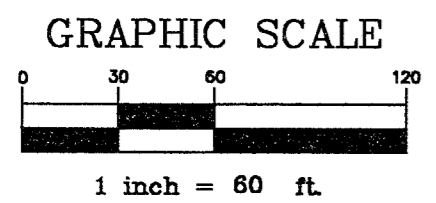
### BASIS OF BEARINGS

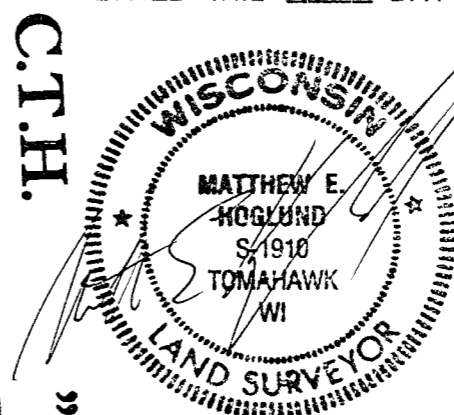
