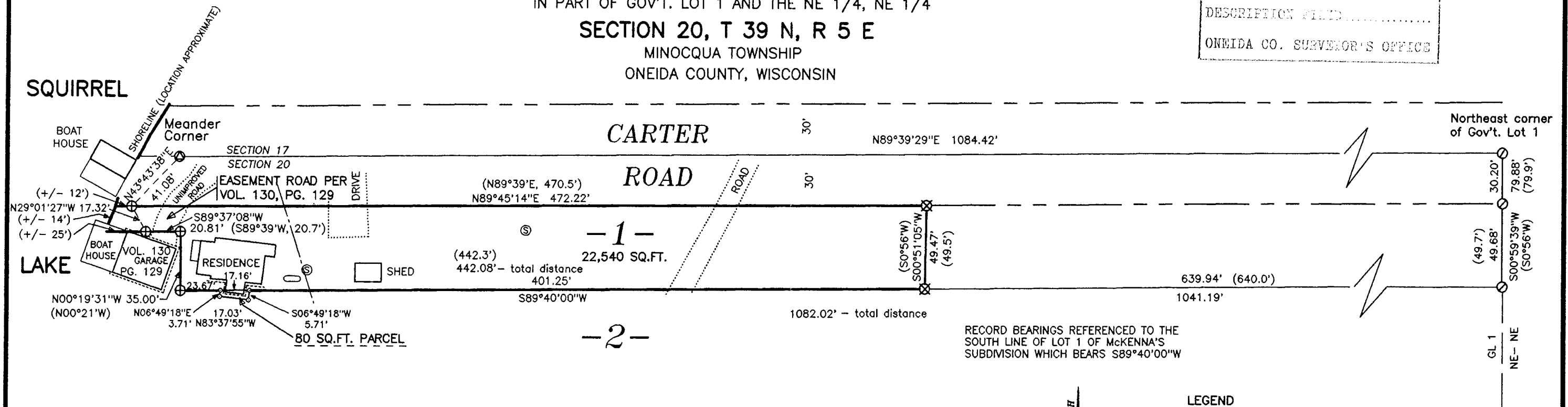

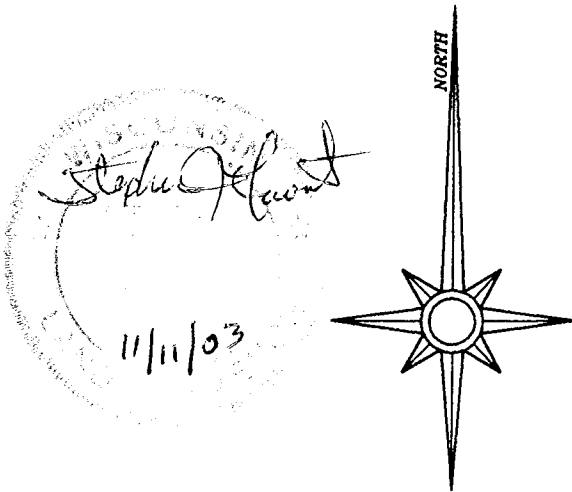

**80 SQ.FT. PARCEL DESCRIPTION**

A parcel of land in Lot 2 of the Plat of McKenna's Subdivision, said Lot 2 located in part of Government Lot 1 and part of the NE 1/4 of the NE 1/4, Section 20, Township 39 North, Range 5 East, Minocqua Township, Oneida County, Wisconsin, more particularly described as follows: Commencing at the meander corner common to Sections 17 and 20 near the east shore of Squirrel Lake marked by an Oneida County aluminum capped monument in place; thence North 89 degrees 39 minutes 29 seconds East for a distance of 1084.42 feet to the northeast corner of said Government Lot 1 marked by an iron pipe, thence South 00 degrees 59 minutes 39 seconds West for a distance of 79.88 feet to an iron pipe; thence South 89 degrees 40 minutes 00 seconds West along the north line of said Lot 2 of the Plat of McKenna's Subdivision for a distance of 1041.19 feet to the PLACE OF BEGINNING. Thence South 06 degrees 49 minutes 18 seconds West for a distance of 5.71 feet; thence North 83 degrees 37 minutes 55 seconds West for a distance of 17.03 feet; thence North 06 degrees 49 minutes 18 seconds East for a distance of 3.71 feet; thence North 89 degrees 40 minutes 00 seconds East along the north line of said Lot 2 of the Plat of McKenna's Subdivision for a distance of 17.16 feet to the PLACE OF BEGINNING.
