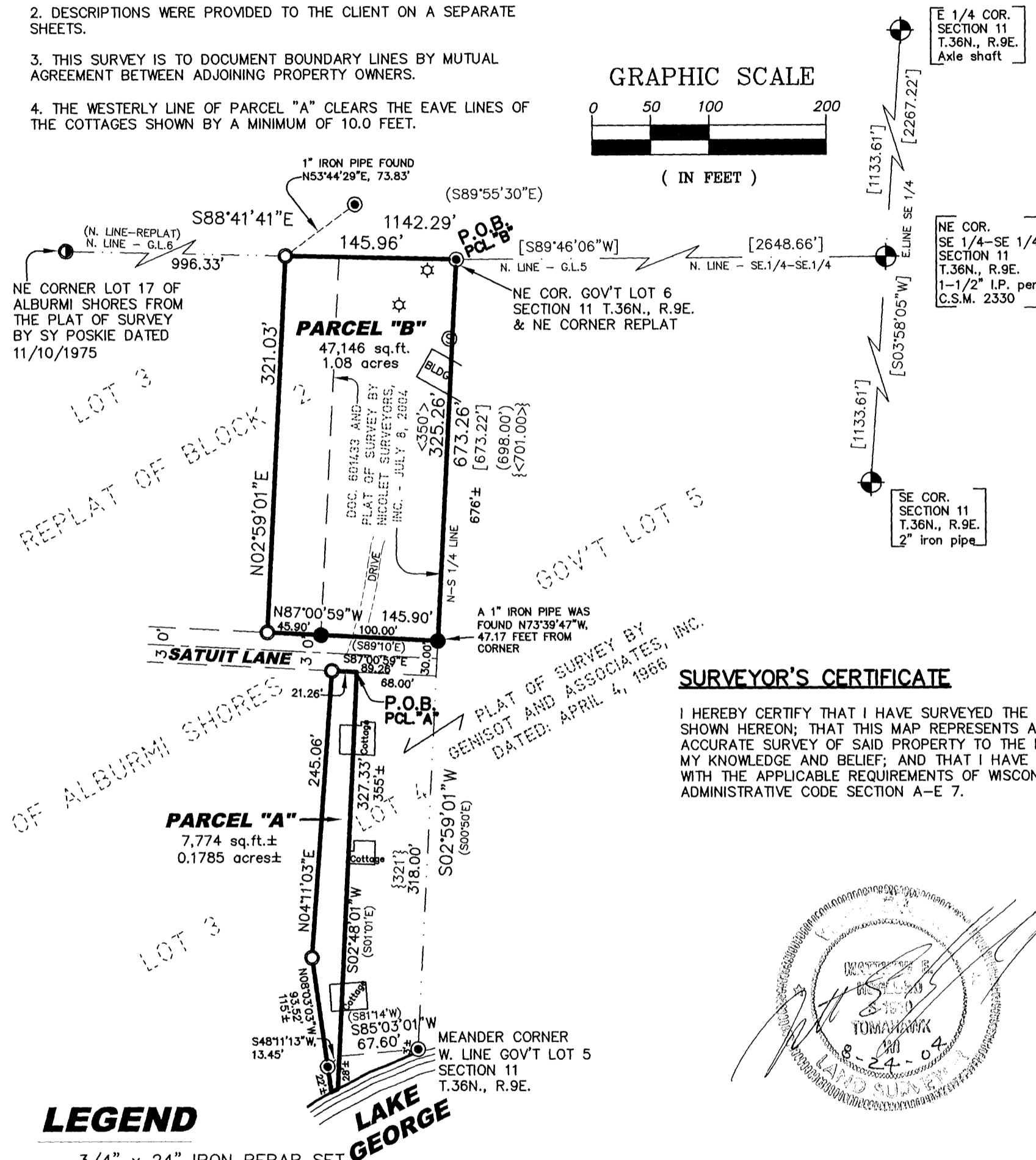
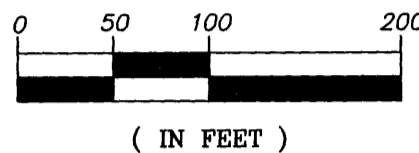
PLAT OF SURVEY
