


SURVEYOR'S CERTIFICATE

I, WILLIAM S. CAMERON, registered land surveyors, hereby certify:

That in full compliance with the provisions of Chapter 236 of the Wisconsin Statutes and the subdivision regulations of the Town of Woodruff, and under the direction of Robert E. Serns and Mary C. Serns, owners of said land, I have surveyed, divided and mapped NAWAII SHORES, that such plat correctly represents all exterior boundaries and the subdivision of the land surveyed: Being a parcel of land in Gov't. Lot 5, Section 19, T39N, R7E, Oneida County, Wisconsin, more particularly described as follows:

Commencing at the one-quarter corner common to Sections 19 and 24, marked by a round iron rod; thence $N84^{\circ}-25'$ E, 554.26 feet to the place of beginning, marked by an iron rate.
