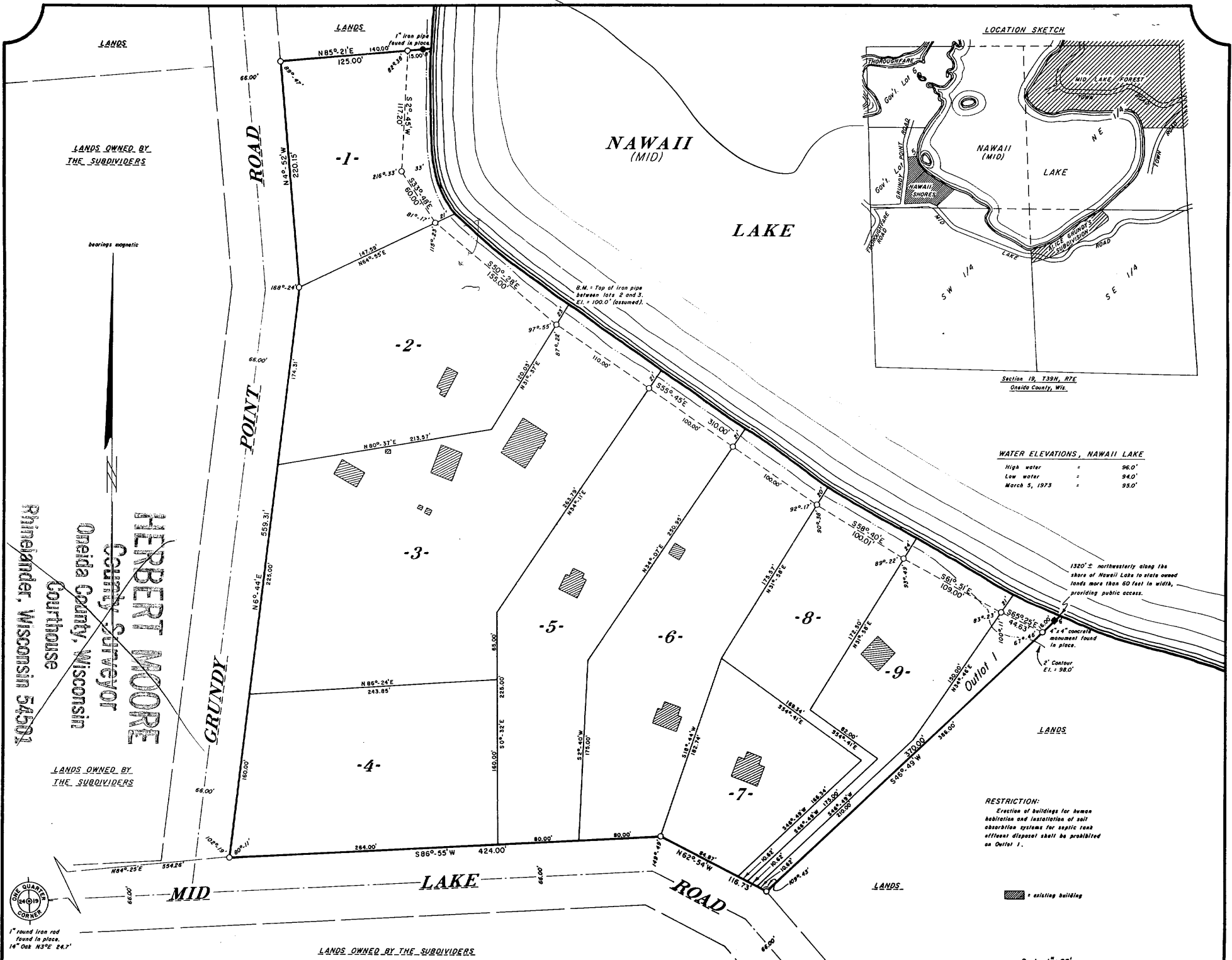

SURVEYOR'S CERTIFICATE

I, WILLIAM S. CAMERON, registered land surveyors, hereby certify:
 That in full compliance with the provisions of Chapter 236 of the Wisconsin Statutes and the subdivision regulations of the Town of Woodruff, and under the direction of Robert E. Serns and Mary C. Serns, owners of said land, I have surveyed, divided and mapped NAWAII SHORES, that such plat correctly represents all exterior boundaries and the subdivision of the land surveyed: Being a parcel of land in Gov't. Lot 5, Section 19, T39N, R7E, Oneida County, Wisconsin, more particularly described as follows:
 Commencing at the one-quarter corner common to Sections 19 and 24, marked by a round iron rod; thence N84°-25'E, 554.26 feet to the place of beginning; marked by an iron pipe.
 Thence N6°-44'E, 559.31 feet to an iron pipe; thence N4°-52'W, 220.15 feet to an iron pipe; thence N85°-21'E, 125.00 feet to an iron pipe near the westerly shore of NAWAII LAKE; thence meandering along the Lake, S2°-45'W, 117.20 feet; S33°-48'E, 60.00 feet; S50°-28'E, 155.00 feet; S55°-45'E, 310.00 feet; S58°-40'E, 100.01 feet; S61°-51'E, 109.00 feet and S65°-25'E, 44.63 feet to an iron pipe; thence S46°-49'W, 370.00 feet to an iron pipe; thence N62°-54'W, 116.73 feet to an iron pipe; thence S86°-55'W, 424.00 feet to the place of beginning.
 Including also all lands lying between the meander lines and the shore of NAWAII LAKE.
 That = iron pipe two inches in diameter and 30 inches long, minimum weight 3.65 pounds per lineal foot. All other lot corners monumented with iron pipe one inch in diameter and 24 inches long, minimum weight 1.13 pounds per lineal foot.
