Michelson Parcel (Map No. 05-38)

A parcel of land located in Government Lot 5, section 9, Township 38 North, rang 6 East, Hazelhurst Township, Oneida County, Wisconsin, being the "Michelson" parcel shown on Map No. 05-38 by Oestreich Surveying & Mapping, LLC, dated December 14, 2005, more particularly described as follows:

Commencing at the east quarter corner of Section 9, marked by a P.K. Nail in the pavement of Cedar Falls Road; thence South 82 degrees 58 minutes 00 seconds West for a distance of 1257.78 feet to the northwest corner of Government Lot 5, being the Center-East Sixteenth Corner; thence South 02 degrees 24 minutes 49 seconds East for a distance of 847.09 feet along the west line of Government Lot 5 to a Meander Corner, marked by an iron pipe near the northerly shore of Upper Kaubashine Lake; thence meandering along the lake South 83 degrees 49 minutes 11 seconds East for a distance of 98.88 feet to an iron pipe; thence continuing along the lake South 69 degrees 28 minutes 26 seconds East for a distance of 2.43 feet to the place of beginning, marked by a cement nail.

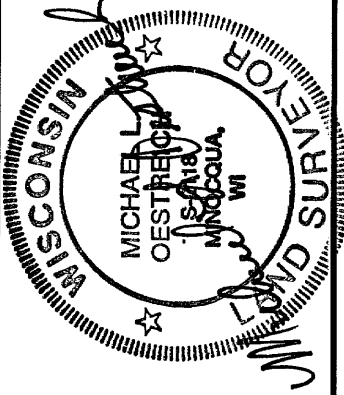
Thence North 02 degrees 24 minutes 49 seconds West for a distance of 420.00 feet to an iron rod; thence South 69 degrees 16 minutes 37 seconds East for a distance of 267.97 feet to an iron pipe; thence South 20 degrees 57 minutes 29 seconds West for a distance of 385.87 feet to an iron pipe near the northerly shore of Upper Kaubashine Lake; thence meandering along the lake North 69 degrees 28 minutes 26 seconds West for a distance of 101.36 feet to the place of beginning.

The above lateral lot lines extend to the Upper Kaubashine Lake, and include all lands lying between the meander line and the ordinary high water mark.

Together with and subject to covenants, easements, and restrictions of record.

Said property contains 1.64 acres more or less.
