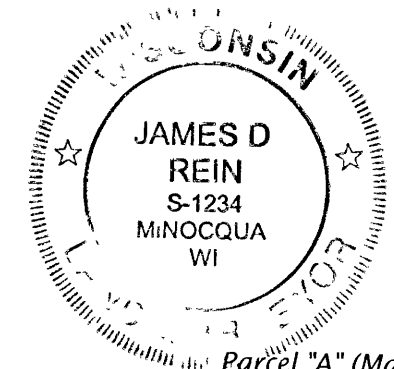

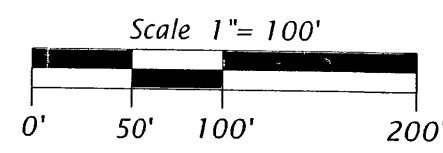
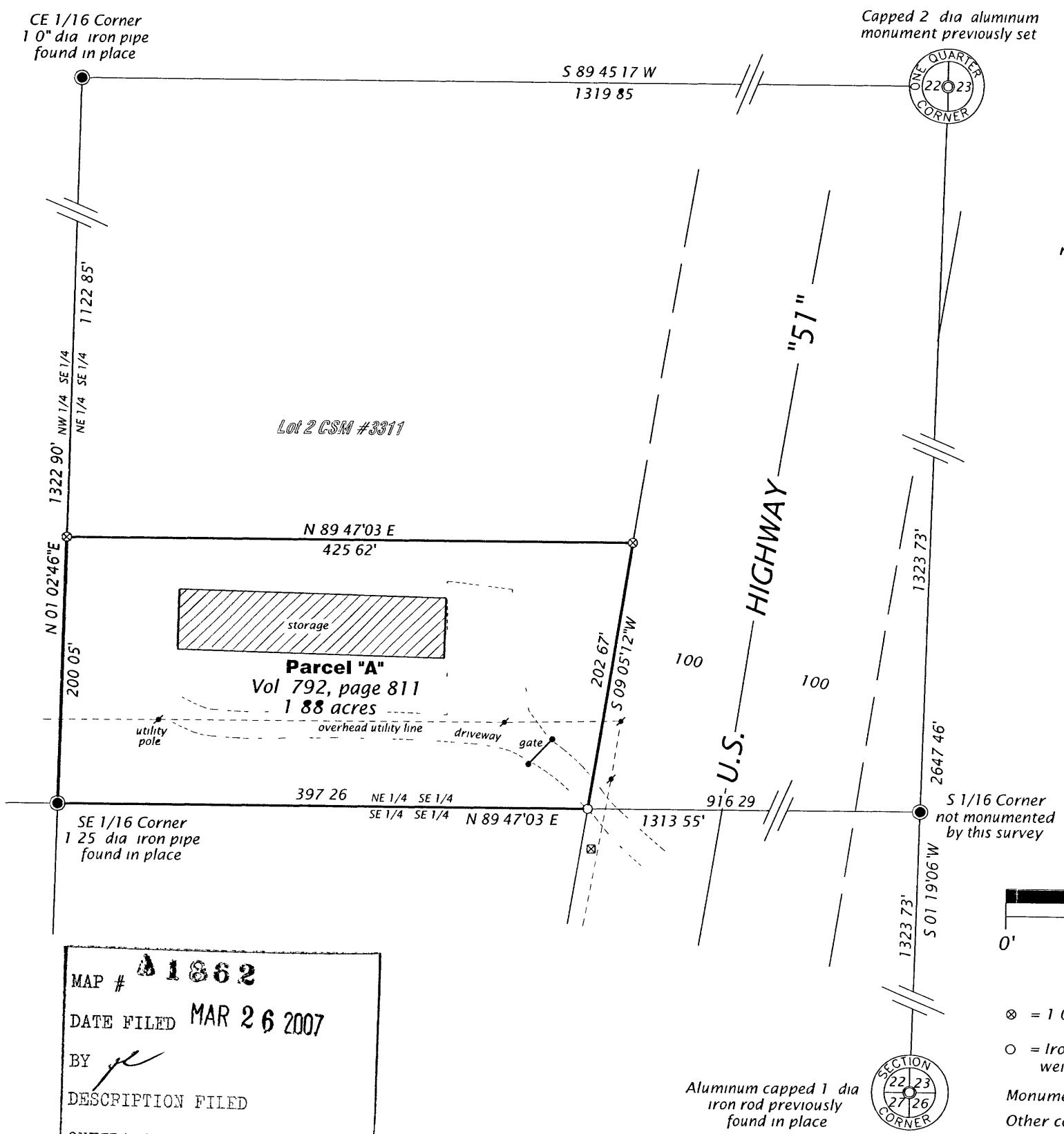
A parcel of land in the northeast quarter of the southeast quarter Section 22 Township 38 North Range 6 East Town of Hazelhurst Oneida County Wisconsin being parcel A shown on Map No 07 16 dated February 14 2007 more particularly described as follows

Commencing at the quarter corner common to Sections 22 and 23 marked by a capped aluminum monument thence South 01 degrees 19 minutes 06 seconds West for a distance of 1323 73 feet along the east line of the northeast quarter of the southeast quarter of Section 22 to the southeast corner of the northeast quarter of the southeast quarter of Section 22 being the south sixteenth corner thence South 89 degrees 47 minutes 03 seconds West for a distance of 916 29 feet along the south line of the northeast quarter of the southeast quarter to the place of beginning marked by an iron pipe on the westerly right of way line of U S Highway '51

Thence continuing along the south line of the northeast quarter of the southeast quarter South 89 degrees 47 minutes 03 seconds West for a distance of 397 26 feet to the southwest corner of the northeast quarter of the southeast quarter being the southeast sixteenth corner marked by an iron pipe thence North 01 degrees 02 minutes 46 seconds East for a distance of 200 05 feet along the west line of the northeast quarter of the southeast quarter to an iron pipe at the southwest corner of Lot 2 of Oneida County Certified Survey Map No 3311 thence North 89 degrees 47 minutes 03 seconds East for a distance of 425 62 feet along the south line of Lot 2 of Oneida County Certified Survey Map No 3311 to an iron pipe on the westerly right of way line of U S Highway 51 thence South 09 degrees 05 minutes 12 seconds West for a distance of 202 67 feet along said right of way line to the place of beginning
