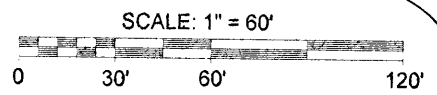

DESCRIPTION

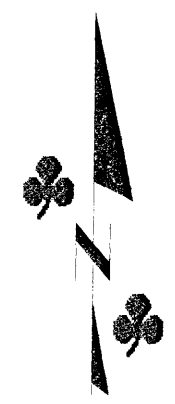
Part of Government Lot 6, Section 4, Township 38 North, Range 6 East, town of Hazelhurst, Oneida County, Wisconsin shown on a survey map by McMullen & Associates, Incorporated of Minocqua, Wisconsin dated the 14th Day of June, 2007 with a Job No. of 207045 and more particularly described as follows:

Commencing at the South 1/4 Corner of said Section Marked by a 2" Iron Pipe; thence North 2° 28' 17" West (Assumed North, based on the Southeasterly line of parcel described herein which bears South 47° 30' 00" West), a distance of 1273.61 feet to a 1 1/4" Iron Pipe, said point being the POINT OF BEGINNING.

Thence North 48° 29' 20" West, a distance of 343.11 feet to a 2" Iron Pipe near the Easterly shore of Lower Kaubashine Lake; thence meandering along said lake shore the following courses: North 11° 20' 00" West, a distance of 75.00 feet; North 43° 26' 56" West, a distance of 80.00 feet; North 31° 21' 59" East, a distance of 95.00 feet to a 2" Iron Pipe; thence leaving said lake shore South 52° 08' 55" East, a distance of 519.14 feet to a 1 3/4" Iron Pipe in the right-of-way of Scalbom Drive; thence South 47° 30' 00" West, a distance of 179.96 feet to the POINT OF BEGINNING.

The above lateral lot line extend to Lower Kaubashine Lake including all riparian rights thereto.
 Subject to and Together with easements described in Volume 816 on Page 306.

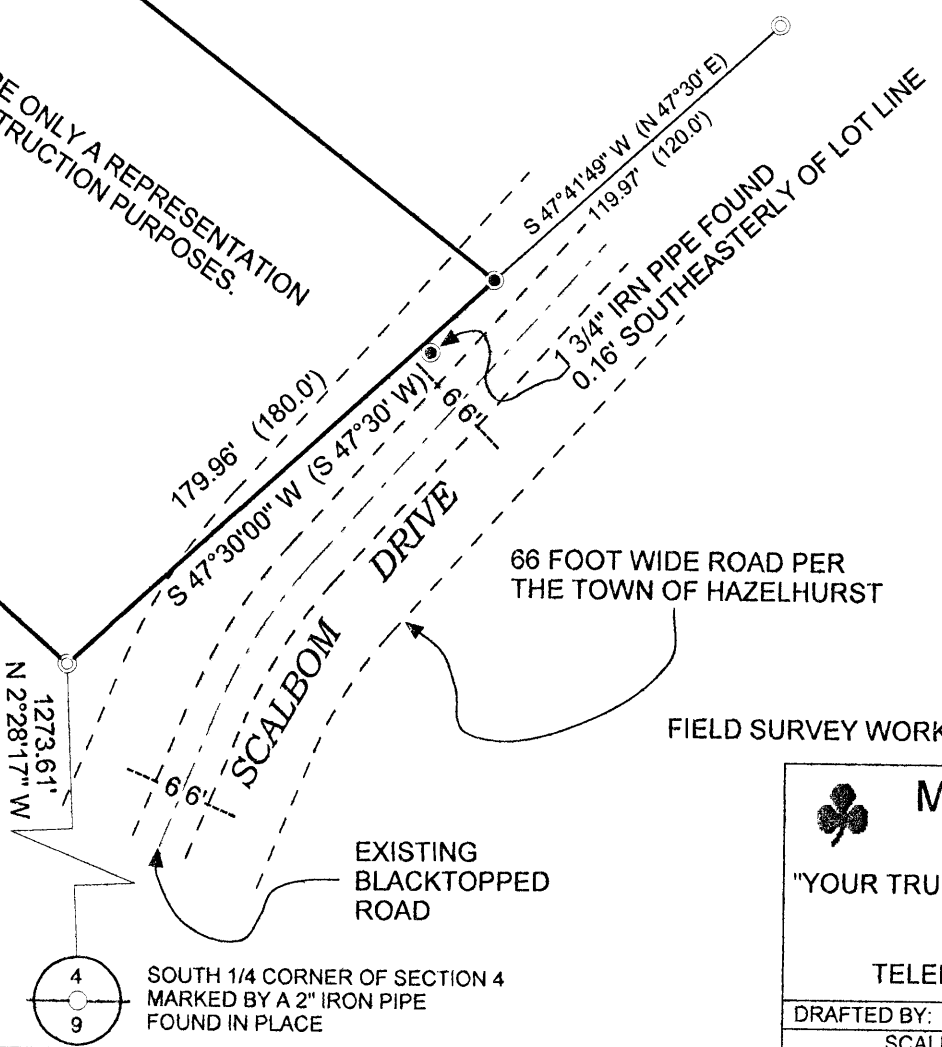
