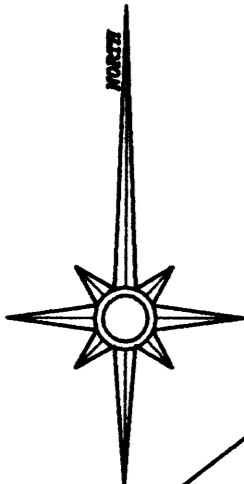


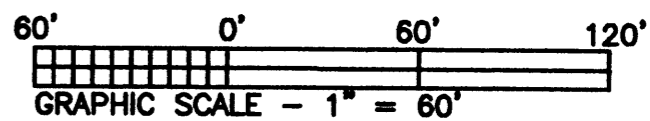
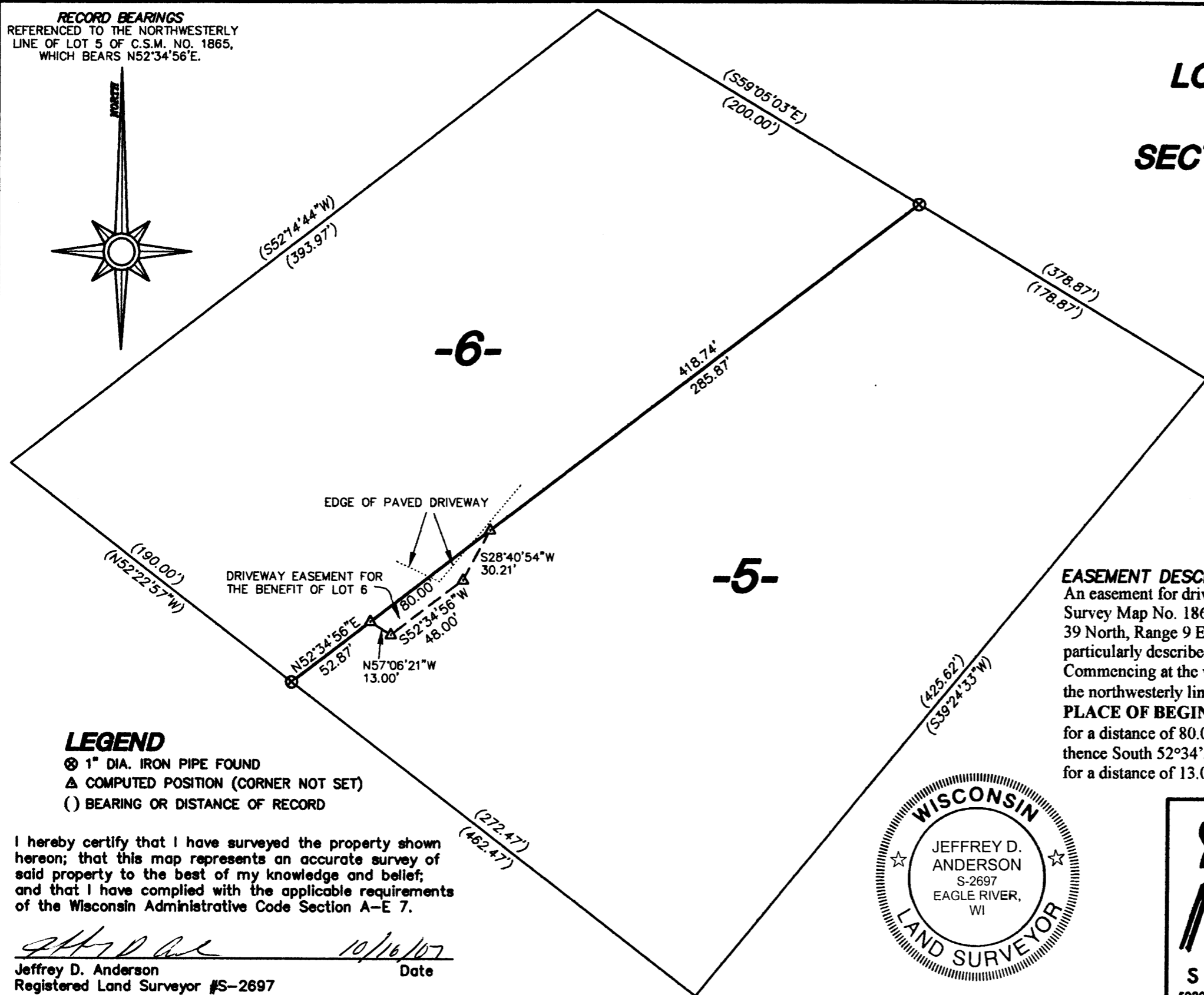

EASEMENT DESCRIPTION

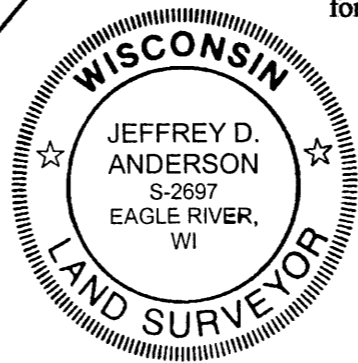
An easement for driveway purposes for the benefit of Lot 6 over Lot 5 of Certified Survey Map No. 1865 being located in part of Government Lot 5, Section 28, Township 39 North, Range 9 East, Town of Sugar Camp, Oneida County, Wisconsin, more particularly described as follows:
Commencing at the westerly corner of said Lot 5, marked by an iron pipe; thence along the northwesterly line of Lot 5 North 52°34'56" East for a distance of 52.87 feet to the **PLACE OF BEGINNING** of said easement. Thence continuing North 52°34'56" East for a distance of 80.00 feet; thence South 28°40'54" West for a distance of 30.21 feet; thence South 52°34'56" West for a distance of 48.00 feet; thence North 57°06'21" West for a distance of 13.00 feet to the **PLACE OF BEGINNING**.
