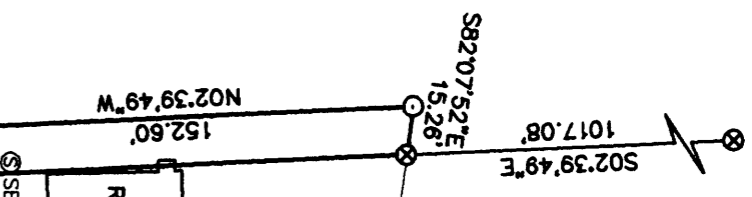


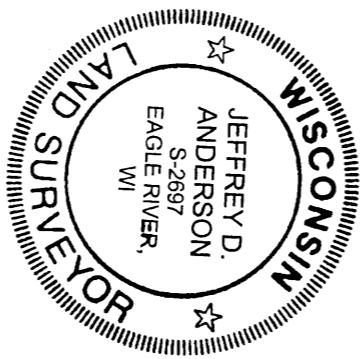
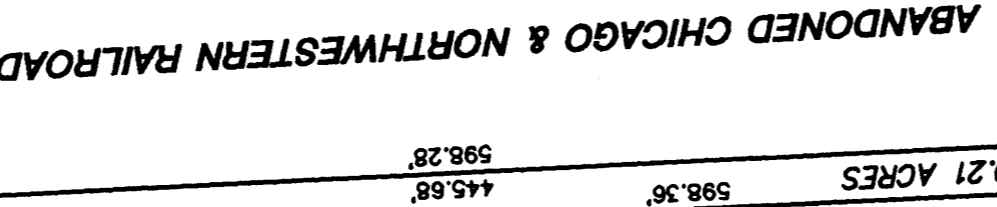

0.21 ACRE PARCEL DESCRIPTION

A parcel of land located in part of the SW 1/4 of the SW 1/4, Section 24, Township 39 North, Range 10 East, Town of Three Lakes, Oneida County, Wisconsin, more particularly described as follows:
 Commencing at the southwest corner of said Section 24, marked by an Oneida County aluminum monument; thence along the section line South 81°31'54" East for a distance of 1101.53 feet to an iron pipe on the easterly line of the abandoned railroad; thence along said railroad North 02°39'49" West for a distance of 614.63 feet to an iron pipe; the **PLACE OF BEGINNING**. Thence leaving said railroad North 81°49'31" West for a distance of 15.27 feet to an iron pipe; thence North 02°39'49" West for a distance of 598.28 feet to an iron pipe; thence South 82°07'52" East for a distance of 15.26 feet to an iron pipe on the easterly line of said railroad; thence along said railroad South 02°39'49" East for a distance of 598.36 feet to the **PLACE OF BEGINNING**. The above-described parcel is to be attached to the adjoining lands to the east and is not to be conveyed separately unless in compliance with Oneida County Subdivision Ordinance.

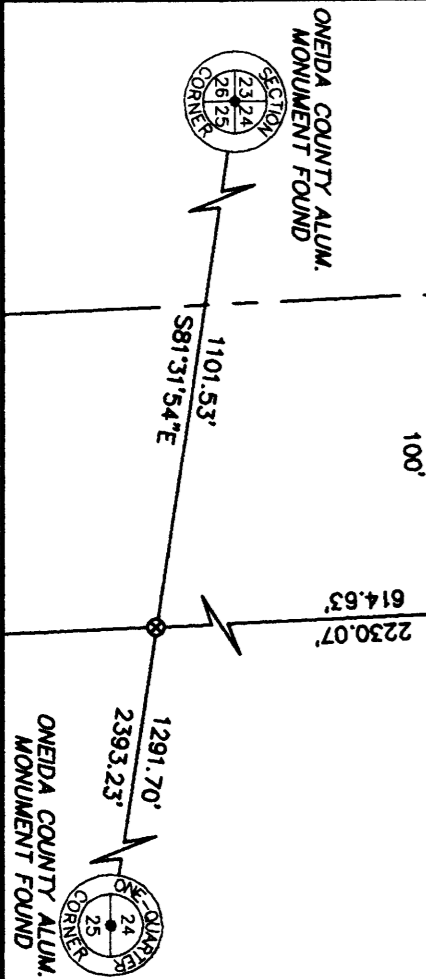
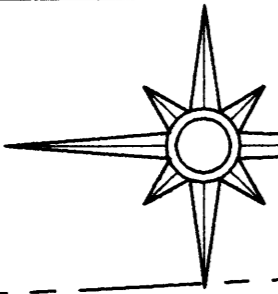
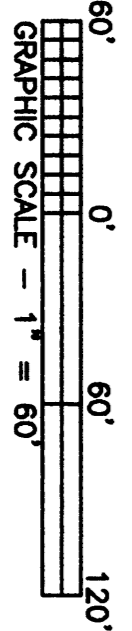
